See particularly numbers five and ten in the list of items for an Application. In short, we seek two changes to the Application:

To add the DRS brand PhotoScribe scanners currently certified under the ASSURE voting system to Democracy Suite, and

To bring the system version of the candidate voting system to 4.14.

- **4-5** the candidate voting system name is unchanged-- Democracy Suite. The system version is changed to 4.14.
- **6. EAC Accredited VSTL:** unchanged, Wyle Laboratories
- 7. Requested EAC Certification Number: unchanged
- **8. Configuration:** unchanged from the approved Application. In short, the ImageCast Evolution is the accessible voting station for this system, along with ImageCast Precinct when used in its audio enabled configuration.
