 - ❑ Press Releases informative for news articles
 - ❑ Polling place finder with sample ballots, links to candidate filings & candidate web sites
 - ❑ Lookups for voter registration status and absentee ballot status (UOCAVA and domestic)
 - ❑ Caucus location lookup
 - ❑ Election Results for state and local races
 - ❑ Online videos for what voters can expect, using electronic voting equipment

State & Political Party Interaction

- ❑ Electronic data to/from Political Parties
 - ❑ Yearly subscription to VR public information list data
 - ❑ Caucus locations
 - ❑ Poll worker lists
