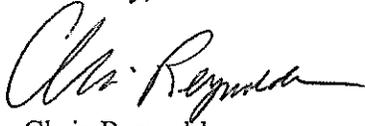
Enclosed please find the original, signed amended Financial Status Report (FSR 269) for HAVA Title II, Section 251 expenditures, covering the period from October 1, 2003 to September 30, 2005. This amended report is being provided pursuant to the letter received by the California Secretary of State dated February 27, 2007. Reference: Amended HAVA Reports Title II, Section 251 for Fiscal Year 2005.

As requested, California is reporting on annual expenditure of proceeds from the state General Fund- supported \$200 million Voting Modernization Bond Act of 2002 that the state identified in its 2003 State Plan as its source of the (5%) matching funds.

Further, as requested, California is submitting annual budget figures for the Secretary of State Election Division from the baseline period that includes the November 2000 general election and each subsequent year. This information is being provided for purposes of reflecting California's "maintenance of effort" (MOE) referenced in HAVA Section 254 (a)(7). It should be noted that California has asked for clarification on how to calculate the MOE because of the specific reference in HAVA to an MOE that maintains support for programs for which funding is being provided (i.e. Title III requirements). As we discussed, until that clarification is provided, California will report the information included here to fulfill this reporting requirement. It should be noted also that California did not begin expending any Title II funds to meet Title III requirements until calendar year 2006. These funds are appropriated separately from state General Funds, which support the state's Election Division budget, and there may be fluctuations in the Election Division budget because of General Fund shortfalls. Such shortfalls do not affect the level of support necessary to meet HAVA mandates. The state has not supplanted any state funding with federal HAVA funding. And at no time has the state's General Fund support for the Secretary of State's Election Division dropped below the 1999-2000 "baseline."
