**Description of Help America Vote Act Spending Programs**

The program expenditures listed below are the expenditures authorized by the State of Connecticut, State Plan and represent HAVA spending from January 1, 2005 to December 31, 2005. More specifically, these expenditures are authorized pursuant to section "J" Effect of Title I Payments, page 18 of the State of Connecticut, State Plan.

**I) State Plan – Election Administration Redesign and Reform Management.**  
**\$330,357.95**

The Office of the Secretary of the State established a position entitled Help America Vote Act Coordinator and has developed a durational positions whose sole duty is to draft and administer our RFP process for new voting machines. The Coordinator is charged with ensuring that all requirements of the Help America Vote Act are met in the State of Connecticut. This includes, but is not limited to supervision of printed materials and ballots, implementation and maintenance of the Centralized Voter Registration System, participation in the review and purchase of compliant voting systems, communication with our 169 municipalities regarding Help America Vote Act implementation at the local level and to ensure that all funding and resources given to municipalities are used in a manner that is compliant with the provisions of the Help America Vote Act. The Coordinator and Secretary of the State staff also attend yearly educational conferences regarding HAVA implementation.

**Salaries & Wages-----\$87,237.92**

The Office of the Secretary of the State completed its Centralized Voter Registration System (CVR) in 2004. The ongoing costs to maintain CVR include: IT Data Services, Hardware Maintenance, and ISDN Telecommunication Services.

**II) Voter Education and Poll Worker Training.**  
**\$344,070.11**

The Office of the Secretary of the State continued various voter education efforts and poll worker training sessions in 2005 to ensure that the general public and local election officials fully understood and could comply with the provisions of the Help America Vote Act. Educating voters on voting rights, voting procedures and voting technology is a priority.

Our voter education and training efforts focused on the future use of accessible voting machines in Connecticut. Specifically, on the federal requirements for the purchase of new voting machines, the contracting process in Connecticut for the purchase of new voting machines, the status of the purchase of new voting machines, details about the new voting machines, the role of municipalities and local election officials and Connecticut's next steps. In addition, our office conducted education and training sessions regarding the new voting machines and their proper use.


In November 2005, the top voting machine vendors participated in public demonstrations in each of Connecticut's five Congressional Districts where Mayors, First Selectmen, Registrars of Voters, Town Clerks and members of the public (including persons with disabilities) were given an opportunity to rate and evaluate the machines. The University of Connecticut managed the process and reported on the evaluation of each machine. The University of Connecticut also conducted a focus group for people with disabilities at each demonstration location. In addition to the public demonstrations, we provided the opportunity for registrars of voters and town clerks to grade each vendor on their training process.

Finally, our office met with and corresponded, both in writing and through the use of the media, with the public, local election officials, including poll workers, on several occasions regarding the procedures to be used for new voting machine implementation.
