As requested by the U. S. Election Assistance Commission, listed below is a detailed list of expenditures and a description of related activities conducted by the Kentucky State Board of Elections during the calendar year 2003 utilizing HAVA, Title I, Section 102 funds.

Replacement of Lever Voting Machines - \$239,416.50

Three (3) counties for a total of 75 precincts were reimbursed for their replacement of lever voting machines as required by Help America Vote Act (HAVA). Reference to lever voting machines can be found on page 20, of Commonwealth of Kentucky – State Plan.
