OCTOBER 2004 THROUGH SEPTEMBER 2005**

As requested by the U.S. Election Assistance Commission, listed below is a detailed list of expenditures and a description of the related activities conducted by the Kentucky State Board of Election utilizing Help America Vote Act (HAVA), Title II, Section 251 funds during the period from October 1, 2004 through September 30, 2005

Absentee Ballot System - \$13,440.00

Working with Kentucky's Commonwealth Office of Technology, the statewide database for absentee ballot applications was upgraded.

Reference to enhancement of the statewide voter registration system can be found on page 17 of the State Plan.

Voting Equipment for all Polling Locations - \$609,450.00

Reimbursements were paid to the counties for voting equipment upgrade for in-house and mail-in absentee voting process as required by HAVA with equipment being certified by the State Board of Elections; reimbursement to counties for purchasing voting equipment that must be accessible for individuals with disabilities as required and certified by the State Board of Elections.
