RE: SF 269 *Long Forms*

Dear Mr. Wilkey:

In the Louisiana Department of State's State Plan dated August 1, 2003, \$654,360 of reimbursement funds for Louisiana's five percent state match required by Section 253(b)(5) of HAVA was to be transferred from Title I, Section 102 funds to Title II, Section 251 funds. However, this plan was amended and it was determined that all of Title I, Section 102 funds would be used for replacement of non-compliant lever voting systems and upgrade of existing voting systems for disability access.

On November 10, 2006, the Louisiana Department of State approved an amended State Plan for the State of Louisiana. As a result, it was necessary for the Department to amend SF 269 forms which have already been submitted to the U.S. Election Assistance Commission. Our amended forms includes the requested amended HAVA report for Title II, Section 251 for Fiscal Year 2004 detailed in your January 10, 2007 letter to Secretary Jay Dardenne. All amended forms utilized the model SF 269 *Long Form* in your letter. In addition, we have provided you with a breakdown of our budget and expenditure allocations based upon the amended state plan, maintenance of effort information, interest breakdown, and state budget allocations for the five percent state match.


