

REPORT ON EXPENDITURE OF TITLE I, SEC. 101 FUNDS DURING CY 2005**

Title I, Sec. 101

In accordance with HAVA Section 101(b) and the Missouri state plan, Missouri used the Section 101 funds covered in this report to provide a series of election improvement grants to a number of local election authorities. (*State Plan, page 37*)

Election Improvement Grants - \$710,500

Election improvement grants to local election authorities were funded under Section 101. In Calendar Year 2005, 22 jurisdictions received a total of \$710,500. The grants were based on the number of precincts in each jurisdiction, at \$250 per precinct, with a minimum grant of \$15,000. The grants could be used at the discretion of the local election authority to improve the administration of elections. Local authorities applied the funds to such areas as poll worker training, voter education, voting technology, and voting equipment (*State Plan, page 37*).

Voter Education - (\$112,156 adjustment)

The previous Missouri Secretary of State placed ads in newspapers across the state for voter education purposes prior to the November 2004 election. The current administration determined in 2005 that these expenditures would be funded with state funds rather than federal funds. The adjustments were made accordingly.

Interest Earned - \$103,966

The Missouri Secretary of State invested Title I, Sec. 101 funds during the reporting period and accrued interest in the amount of \$103,966.
