As you know, we have received your letters regarding Montana's Amended SF 269 reports. On January 24, 2007, your office granted us an extension for these amended reports.

Below is a summary of the information required, in addition to our office's response to each item.

## **Title I, Section 101**

- ◆ *Report interest earned on deposits of these funds into your State HAVA account. It must be added to your total federal share and shown on Line 10 of as a combined total, and the amount footnoted on Line 12.*

## **Response:**

- ◆ This office did not initially allocate interest funds to separate account numbers for Title I and Title II funds, so all funds were pooled instead of being placed in Title I and Title II accounts. However, based on our HAVA spending, for the purposes of the Title I amended report attached we have reviewed our Title I expenses during the applicable period and accordingly have apportioned percentages of the total interest earned to Title I. We trust that this method will be acceptable and meets the applicable requirements for reporting.

## **Title II, Section 251**


- ◆ *Report interest earned on deposits of these funds into your State HAVA account. It must be added to your total federal share and shown on Line 10 o as a combined total, and the amount footnoted on Line 12.*
- ◆ *Interest is also earned on your State's match. This interest must also be reported, separately, totaled with the match and footnoted on Line 12.*
- ◆ *Please add a separate entry on Line 12, to note the maintenance of effort (MOE) for the State fiscal years covered by the report. For example, if your State fiscal year runs from July 1 to June 30, then the report covering Title II requirements payments activities from October 1, 2004 to September 30, 2005 should disclose on Line 12 the amount expended in MOE funds from July 1, 2004 to June 30, 2005 and the amount budgeted for the MOE for the period from July 1, 2005 to June 30, 2006.*

**Response:**

- ◆ As noted above, this office did not initially allocate interest funds to separate account numbers for Title I and Title II funds, so all funds were pooled instead of being placed in Title I and Title II accounts. However, based on our HAVA spending, for the purposes of the attached Title II amended report we have reviewed our Title II expenses during the applicable period and accordingly have apportioned percentages of the total interest earned to Title II. Again, we trust that this method will be acceptable and meets the applicable requirements for reporting.
- ◆ For the purposes of the state match, our office has asked the county election administrators to provide funds for the match. The election administrators did so through their own funds and did not accrue interest on those funds. Therefore, there is no interest to be reported for the match, and this is noted on the attached amended report.
- ◆ In regard to the maintenance of effort, we have added separate information on Line 12 to report the state's maintenance of effort. We understand that this is meant to reflect how Montana, in using the requirements payment, maintained the expenditures of the state for activities funded by the payment at a level that was not less than the level of such expenditures maintained by the state for the fiscal year ending prior to November 2000.

As noted above, we have attached the amended 2004 and 2005 Title I and Title II reports for your review. If there are any errors or omissions on the attached, please let me know as soon as possible and we will make any necessary corrections or additions.



Remarks: Attach any explanations deemed necessary or information required by Federal sponsoring agency in compliance with governing legislation: The 5% match was paid by Missoula County on February 23, 2004 for precinct counters that cost \$432,960.00. Our office reimbursed the county for \$216,480.00, leaving an amount of \$216,480.00 paid by the county for matching. This amount was more than the federal match requirement of \$207,500 (5%) for the \$4,150,000.00 outlay. This match is included as part of the total outlay on Line 10d. and Line 10h. All of the match was expended before the requirements payment was received. There was no interest on this match since it came from the county. All interest from HAVA funds was pooled and not originally allocated separately to Title I and II, but it was estimated based on spending and included on Line 10o in the amount of \$8,102.82. In FY 2000, our elections expenses totaled \$160,288.17. For the state fiscal year July 1, 2003-June 30, 2004, non-HAVA MOE totaled \$301,890.40. For the state fiscal year July 1, 2004-June 30, 2005, non-HAVA MOE totaled \$345,425.41.
