Enclosed is the 2006 Section 101 HAVA funds report. Discussion of Section 101 transactions (per the enclosed expenditures and expense detail attachments) are set out below.

AID AND EQUIPMENT

There were no expenditures in this area. Refunds from a few counties in this area totaled \$2,915.06.

COMPUTER

\$21,778.00 was granted to counties to purchase personal computers and printers for improvements in county election administration.

LABOR

Total labor/consulting costs of \$144,185.67 were incurred. As set out in the attached detail, the consulting and labor were performed in the area of improving our statewide voter registration database (SEIMS), escrowing voting system software/firmware, consulting on the selection and certification of voting systems, and recording hearings/meetings that dealt with voting system certification.

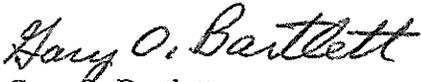
