Dear Election Assistance Commission:

Pursuant to 42 USC §15408, (Section 258 of HAVA), North Carolina submits the Federal FY04 (October 1, 2004-September 30, 2005) report covering activities during that period of time of HAVA Title II requirement funds.

Enclosed is Form 269 report of Title II requirement funds activity for FY04. On June 17, 2004, North Carolina received \$23,431,708 in FY03 HAVA Title II requirement funds. On August 23, 2004, North Carolina received \$42,046,100 in FY04 HAVA Title II requirement funds. This was supplemented by a total of \$3,444,133 in state matching funds appropriated by the North Carolina General Assembly prior to the delivery of the federal HAVA Title II requirement funds.

As required by Section 258(1), total expenditures of the Title II requirement funds in FY04 were \$1,247,024.86 with expenditures made in two areas:

1. \$1,268,179.46 for aid and equipment to the counties. Details to this expense is attached to the form 269.
2. \$ (21,154.60) for time-limited employee positions. Details to this expense is attached to the form 269.

As required by Section 258(2) no expenditures of Title II HAVA requirement funds were made for articles of voting equipment in FY04. For your information, major expenditures for voting equipment are now being made and will be reflected in the FY05 report.

As required by Section 258(3) an analysis and description of the activities funded are set out below:

Aid and Equipment to Counties (Grants)

Technology Grants were made in FY2004 to counties to improve election administration. The purpose of the program was to bring the technology level of county elections offices up to a level that would allow them to more efficiently operate in their day to day operations. This program was budgeted in the North Carolina State HAVA Plan. The budget is set out in Section Six of the plan and includes in its next to last line item, "County Technology Improvements".

These county grants also directly improved the operations of the State Election Information Management System (SEIMS), containing both the statewide voter registration database and election administration programs. As of the summer of 2005, SEIMS operated on a real-time basis with all 100 of North Carolina counties. Numerous SEIMS and voter registration transactions occur each day with all counties and the county technology grants were needed to make sure the counties and the voters they serve could receive the full benefits and services SEIMS offered.


As noted on the enclosed detail, some funds were transferred from HAVA Title II to HAVA Title I to repay some previous county aid expenditures. This transfer was necessary because some HAVA Title I expenditures were reclassified as HAVA Title II during 2005. There was also a return of unused grant funds by the counties.

Time-Limited Labor Costs

As mandated by Section 303 of HAVA, our statewide computer system containing both the statewide voter registration database and election administration programs, SEIMS, has been and continues to be upgraded to meet the requirements set out in that section. You will note that there was a transfer of some of labor costs for SEIMS HAVA compliance from Title II HAVA funds to North Carolina Maintenance of Efforts (MOE) HAVA funds as set out in the attached detail.
