

HAVA REQUIREMENT – Computerized Statewide Voter Registration List

HAVA, Title I, Section 101 funds in the amount of \$5,065,779.22 were expended by the Commonwealth for the task of developing and implementing Pennsylvania's computerized statewide voter registration list know as the Statewide Uniform Registry of Electors (SURE). These expenditures include:

- Travel cost and conference registration fees for the SURE staff to attend election conferences with the county election directors as well as training cost, educational supplies, printing and advertising used by the Commonwealth in training the county elections staff on the use of the SURE system
- Telecommunications and circuit cost for deployment of the SURE system to the county elections offices.
- Consulting fees paid to Accenture LLP, the contractor responsible for the development and implementation of the SURE system
- Consulting fees paid MicroSoft Inc. for the consulting services of David Burgess, Microsoft Specialist
- Professional service fees paid to NetComm Inc. for LAN development and upgrade costs
- Professional services fees paid to InfoSentry Inc. for a quality assessment review of the SURE system to test the system's readiness for the November 2004 General Election
- System software purchases from ASAP Software Inc. and Nero.com
- Office supplies for the Department of State's SURE Office
- Computer equipment from CISCO Systems and Hewlett Packard for the SURE system
- IBM equipment for upgrades to the SURE system to accommodate Provisional Balloting
- Computer network cables, servers and racks from Eplus Technologies
- Pennsylvania Office of the Budget, Comptroller Services fees

STATE PLAN CONFORMANCE:

Act 3 of 2002 authorizes the establishment of a central uniform registry that is HAVA compliant. Because the Statewide Uniform Registry of Electors (SURE) could not be fully operational by the date specified by section 303(d)(1)(B) of HAVA – January 1, 2004 – the Commonwealth invoked the waiver authorized by HAVA to extend the deadline for full implementation until January 1, 2006.

The Commonwealth's State Plan earmarked Title I, Section 101 funds as partial payment for the cost of the SURE system. By the April 27, 2004 General Primary, 56 of the Commonwealth's 67 counties were using the SURE system as their official record of voter registration. Pennsylvania's 11 remaining counties will be fully connected to the SURE system as soon as possible, but no later than the January 1, 2006 deadline imposed by HAVA.

These expenditures exceed the amount of \$3,500,000.00 allocated in Pennsylvania's State Plan for these tasks. This grant is currently over committed. The unliquidated obligations will be transferred out of the Title I grant and into the Title II grant at a later date.

HAVA REQUIREMENT – Voter Education/Voter Outreach

The Commonwealth for voter education and outreach initiatives expended HAVA, Title I, Section 101 funds in the amount of \$1,058,387.73. These expenditures include:

- Travel expenses for the Department of State's Press Secretary to travel from Harrisburg to Philadelphia to view and approve a video developed for voter education for the Commonwealth
- Installation cost for a toll free line for voter information in the Bureau of Commissions, Elections and Legislation
- Printing cost paid to Digital Ink Inc. for a Felon Voter Guide
- Printing cost paid to Digital Ink Inc. for HAVA Posters
- Cost paid to Red Tetterer for a multimedia advertising campaign to increase voter registration and to educate voters
- Newspaper and program advertising costs
- Printing cost paid to Digital Ink Inc. for a Spanish Voter Guide
- Postage and Freight cost incurred in distribution of voter education and outreach materials

STATE PLAN CONFORMANCE:

The Commonwealth began the implementation of a voter education program in December 2003. Prior to the April 27, 2004 General Primary, the Commonwealth relied on public service announcements, required advertisements in newspapers, and polling place postings to inform voter of their rights and other important information necessary for participation on Election Day. After the 2004 General Primary, the Commonwealth contracted with an advertising firm to conduct a statewide voter education effort for the November 2, 2004 General Election. The contractor integrated TV, radio and print advertisements, billboards, comprehensive voter guides, pamphlets, an instructional video, a new website, and various public events into the voter education program. According to the contractor, our voter education message of "Ready, Set, Vote" reached over nine million Pennsylvanians prior to Election. This initiative was conducted both in English and Spanish. "Ready, Set, Vote" and other voter education initiatives received positive reviews from most county personnel, advocacy groups and the public.

These expenditures fall within the amount of \$2,000,000.00 allocated in Pennsylvania's State Plan for these tasks.

HAVA REQUIREMENT – Election Officer Training

The Commonwealth for election officer training initiatives expended HAVA, Title I, Section 101 funds in the amount of \$24,040.16. These expenditures include:

- Travel cost for county election officers to attend training sessions offered by the Commonwealth
- Office supplies used by Commonwealth staff conducting the county training sessions
- Computer equipment and peripherals used in conducting the county training sessions
- Conference expenses for facilities for county training sessions

STATE PLAN CONFORMANCE:

The Commonwealth conducted several types of seminars and training during 2004. Prior to the Special Elections held in Columbia County on January 27, 2004 and in Montgomery and Philadelphia Counties on March 9, 2004. Prior to the April 27, 2004 General Primary, the Commonwealth offered and conducted training on provision voting, voter identification, and HAVA Title III complaints for all counties that requested training. Thirteen counties accepted the Commonwealth's offer for training.

The Commonwealth also conducted numerous training sessions prior to the November 2004 election. During July 2004, at no expense to the counties, the Commonwealth conducted five regional seminars. The seminars covered various issues relevant to the November 2004 election including voter identification, provisional ballots, HAVA Title III complaints, absentee ballots, alternative ballots, polling place accessibility, polling place postings, processing voters at the polling place, and various other election issues. Sixty-two counties attended the seminars. The goal of the seminars was to promote statewide consistency among all the election procedures.

Prior to the November 2, 2004 General Election the Commonwealth again offered to conduct district election official training seminars for all counties. The training offered for the General Election was a comprehensive review of all Election Day processes. Ten counties requested and were provided with this training.

The Commonwealth is currently working on a more comprehensive election official training program that can be conducted on a statewide basis by January 1, 2006.

These expenditures fall within the amount of \$850,000.00 allocated in Pennsylvania's State Plan for these tasks.

HAVA REQUIREMENT – Alternative Language Assistance

The Commonwealth for alternative language assistance initiatives expended HAVA, Title I, Section 101 funds in the amount of \$8,198.26. These expenditures include:

- Professional fees paid to the Pennsylvania State University for data extractions and maps to determine linguistically isolated Spanish-speaking persons
- Professional fees paid to Sol B. Vasquez-Otero for translation of election documents into the Spanish language
- TRADOS Software purchased for the Commonwealth's HAVA Bilingual Coordinator to aid in translation of election documents from English to Spanish

STATE PLAN CONFORMANCE:

The Commonwealth began to research and implement policies to improve alternative language accessibility in 2003. The Commonwealth required county boards of elections to certify to the Department of State the number of election districts where Spanish-speaking persons comprise 5% or greater of the population as a precursor to receiving HAVA funding. To add the counties in their certifications, the Commonwealth worked with the Data Center at the Pennsylvania State University to develop a set of maps that identify linguistically isolated Spanish-speaking persons. The Commonwealth provided the counties with these maps to assist them in visually identifying areas of their county where election-related materials should be provided in Spanish as well as English. The Commonwealth will implement a similar approach to provide voter services to other limited English proficiency voting populations as their numbers likewise increase and meet the required threshold.

The Commonwealth provided the voter education materials and tools in Spanish throughout the Special Election held in Montgomery and Philadelphia counties on March 9, 2004 and throughout the April 27, 2004 General Primary.

To ensure that the Commonwealth is able to translate necessary materials in a timely and accurate manner and to communicate with Spanish-speaking communities, a bilingual coordinator was hired in August 2004. The coordinator conducted election official training, provided translations for election materials and outreach initiatives to the Spanish-speaking community. This effort includes the Commonwealth's elections website, toll-free telephone line and voter education materials.

These expenditures fall within the amount of \$500,000.00 allocated in Pennsylvania's State Plan for these tasks.

HAVA REQUIREMENT – Administrative /Implementation Costs

The Commonwealth expended HAVA, Title I, Section 101 funds in the amount of \$608,111.46 in administrative costs. These expenditures include:

- Office supplies for the HAVA program staff
- Legal Services fees paid to the Commonwealth's Office of General Counsel for HAVA legal counsel, Gregory Dunlap and Department of State legal counsel, Mark Goodwin
- Membership dues, subscription fees and conference registration fees paid for HAVA program staff and legal staff – NASS, NASED
- EDP/PC leases for HAVA program staff
- Telecommunication charges for the HAVA program staff
- Furniture purchased from Supply Source to accommodate the HAVA program staff
- Copier lease cost, postage and freight cost, building rental and repairs incurred by the HAVA program area
- Pennsylvania Office of the Budget, Comptroller Services fees
- Professional service fees paid to York Stenographic for transcription services at the hearing on the State Plan

STATE PLAN CONFORMANCE:

These costs for the administration of HAVA and its implementation fall within the amount of \$823,168.00 allocated for these purposes in Pennsylvania's State Plan.

HAVA REQUIREMENT – Provisional Voting

The Commonwealth for provisional voting initiatives expended HAVA, Title I, Section 101 funds in the amount of \$91,274.99. These expenditures include:

- Hardware costs paid to E-Plus Technology for alternative methods for reporting provisional voting
- Software costs paid to ASAP software for alternative methods for reporting provisional voting
- Services charges for a toll-free telephone line to handle provisional voting issues for the November 2004 election

STATE PLAN CONFORMANCE:

The Commonwealth, in cooperation with the Department of State, developed and implemented a reporting system that allows counties on the Statewide Uniform Registry of Electors (SURE) to efficiently research the registration status of provisional voters and to report the status of provisional ballots to the Department in a uniform manner. Effective use of this system allowed the Department of State, Bureau of Commissions, Elections and Legislation to quickly upload provisional ballot status information for public consumption as required by the *Election Code*. Counties that were not on the SURE system at the time of the General Election were provided with a program and alternative methods to provide provisional ballot information to the Department of State.

During the April 27, 2004 General Primary, 2,480 provisional ballots were cast statewide. During the November 2, 2004 General Election, 56,558 provisional ballots were cast. Voters were able to call a toll-free telephone number or access a Commonwealth website to determine the status of their provisional ballot.

These expenditures fall within the amount of \$400,000.00 allocated in Pennsylvania's State Plan for these tasks.

These expenditures exceed the amount of \$250,000.00 allocated in Pennsylvania's State Plan for these tasks. This grant is currently over committed. The unliquidated obligations will be transferred out of the Title I grant and into the Title II grant at a later date.
