

**Report of the Commonwealth of Pennsylvania to the

Subject: HAVA Title II Report

Reporting Period: FY2004 - October 1, 2003 to September 30, 2004

The Commonwealth of Pennsylvania through its Department of State has been actively pursuing compliance with the Pennsylvania State Plan originally submitted on July 31, 2003, and amended on August 13, 2004.

The Department met with county personnel in Harrisburg on July 30, 2004 to discuss the process by which HAVA Title II funding is to be distributed for the various purposes outlined in the State Plan. Two additional meetings were held on September 16th and September 22nd to further direct the counties regarding the content of county plans and related documents. The Department has received 43 county grant applications over the last several months and continues its review of county plans, grant agreements and grant applications for HAVA funding. The Department hired a full-time Grants Administrator on September 13, 2004, whose primary responsibility is to work with the HAVA Administrator to ensure county plans and grant agreements are in order and processed correctly and timely.

Originally, county grant applications were due to the Department from the counties on September 15, 2004, and county plans were due October 15, 2004. Because of the volume of information required for county plans and grant applications, and the proximity of the November 2, 2004 General Election the date was extended to January 31, 2005 for all county grant agreements and plans.

The Department authorized a special disbursement of funding to county boards of elections in October. The purpose of the special disbursement was to aid counties that had to hire additional staff and pay for overtime expenses in order to process the record number of voter registration applications received by the counties for the 2004 General Election.

No Title II funding has been released from the Department as of the end of the reporting period for this report.

Report to the United States Election Assistance Commission (EAC)

Subject: Help America Vote Act (HAVA) Title II, Section 251 Expenditures

Reporting Period: October 1, 2004 to September 30, 2005

Introduction

The Pennsylvania State Plan establishes the Commonwealth's goals to comply with HAVA's mandates. As indicated in our State Plan the Election Assistance Commission (EAC) oversees the third, and largest, HAVA funding program under Title II. The principal purpose of the funds provided through the EAC under Title II is to assist the States in meeting the new uniform and nondiscriminatory voting system, election technology and election administration requirements imposed by Title III of HAVA.

Section 251 of HAVA (Title II) authorizes \$3 billion dollars to be appropriated to the States over three Federal fiscal years for "requirements payments" to be used to meet the requirements of HAVA's Title III. Requirements payments may be used to carry out other activities to improve election administration if the State has implemented the requirements of Title III or the amount expended with respect to such other activities does not exceed an amount equal to the minimum payment amount applicable to the State under section 252(c) of HAVA. The Commonwealth received \$35,992,863.00 in Title II requirements payments for Federal Fiscal Year (FFY) 2003, and \$64,585,966.00 for FFY 2004.

The Commonwealth continues to strive to meet its goals of establishing a uniform and nondiscriminatory voting system, improving election technology, and satisfying Title II requirements. The Department of State's (Department) actions taken during the reporting period are summarized below.

Computerized Statewide Voter Registration List

The Department's Division of HAVA (Division) spent \$6,972,650.32 for this category for this reporting period. The Department overcommitted grant funds on the last report submitted. We transferred expenditures to Title II funds on January 13, 2005.

Pennsylvania implemented its Statewide Uniform Registry of Electors (SURE). During this period 42 counties had been converted to the SURE system. The Commonwealth is now compliant with HAVA's centralized voter registration and election management system requirement. The Department designed SURE to ensure Commonwealth voter registration record accuracy and integrity.

Voter Education/Outreach

As stated in the Element 3 of the State Plan *"The Commonwealth believes that voter education is the solution to eliminating much of the confusion that led to the debacle in Florida during the November 2000 election. Therefore, Pennsylvania, through the Department of State, plans to embark on an extensive education effort using all the tools at its disposal to educate its voters regarding their voting rights and the correct procedures to be used at their polling place."*

The Division spent \$1,341,063.41 during this reporting period. The Department launched a program named "Ready> Set> Vote". This campaign included a complete media-advertising program through TV, radio, newspaper ads, panoramic ads, a toll-free telephone line, graphic services, and video development. These expenses also include staff lodging costs and shipping costs.

Poll Worker/ Election Official Training

As Outlined in Element 3 of the State Plan, the Division developed a training program that includes the current law and procedures relative to processing voters on Election Day, the operation of the voting systems, and the procedures to follow when canvassing votes and counting ballots (including absentee and provisional ballots) after the close of the polls.

The Division spent \$7,440.75 for training. Division staff developed and conducted training in 12 counties for polling place accessibility. Staff also developed and conducted seminars in five regions across the Commonwealth. These seminars focused on election administration procedures and uniformity, polling place accessibility, voting system procurement and grants.

Polling Place Accessibility

The Department, as stated in our State Plan, Element 3, disbursed funding in a manner that allowed for the largest number of inaccessible polling places to become accessible. In furtherance of this effort, the Department held meetings with accessibility advocates, including the Polling Place Accessibility Advisory Group formed by County officials and independent groups.

The Department collected survey results from all 67 counties. Of the 9,381 polling places across the Commonwealth, 7,167 have been found to be accessible, 2,198 are inaccessible, and 16 are undefined.

The Division distributed \$18,150.31 in advance payments to counties to comply with Title II, Section 251. The counties used these funds to improve polling place accessibility at inaccessible polling places. Modifications included doorknob purchases, ramp construction, handrail installation, handicapped parking signs, and step elimination.

Alternative Language Assistance

In an effort to improve alternative language accessibility, the Secretary of the Commonwealth formed the Alternative Language Accessibility Advisory Group comprised of advocacy groups for individuals who speak alternative languages as a primary language and various county representatives. The advisory group was established to assess the status of alternative language accessibility across the Commonwealth, provide information, and assist the Commonwealth on how it can increase the number of polling places accessible to individuals who speak alternative languages as a primary language.

All materials designed for use by voters regarding HAVA Title III Complaints, provisional voting and voter identification have been translated into Spanish and provided to the 67 county boards of elections.

The Division did not spend any money on alternative languages during this reporting period. The Department continues to provide election materials, forms (voter registration, absentee ballot, emergency ballot, etc.), and all related election materials in Spanish. In addition, the Department's www.votespa.com website is bilingual.

Administration and Implementation Cost

The Division spent \$65,642.64 during this reporting period. These expenses include: travel expenses, conference attendance fees, office supplies, and other costs directly related to Division operations.

Provisional Voting

The Division of HAVA, in cooperation with the Bureau of Commissions, Elections and Legislation and Bureau of Management Information Systems, developed and implemented a reporting system that allows counties on the Statewide Uniform Registry of Electors (SURE) to efficiently research the registration status of provisional voters and to report the status of provisional ballots to the Department in a uniform manner. Effective use of this system allows the Department to quickly upload provisional ballot status information for public consumption as required by the *Election Code*.

The Division spent \$9.04 during this reporting period.

Miscellaneous/Compliance with the State Plan

The Division spent \$1,511,085.01 for this reporting period. The Department paid a consulting firm for services related to the quality assurance of the SURE system. We transferred expenditures to Title II funds on January 13, 2005. We incurred expenses for advertising the amendment of the Pennsylvania State Plan. This amount also includes money paid to 10 counties for Voter Registration.

Title III Compliance

The requirements mandated by Title III of HAVA are divided into three sections – Section 301 (relating to voting system standards); Section 302 (relating to provisional voting and voting information requirements); and Section 303 (relating to computerized statewide voter registration list requirements and requirements for voters who register by mail). Within each of those sections of Title III are various subsections.

The Division did not incur any expenses for this period.

Improving Federal Election Administration

The Division did not incur any expense for this period.

Voting Systems

The Pennsylvania State Plan, Element 4 states that: *“In accordance with section 222(e) of HAVA, the EAC requires that the current Federal guidelines in effect are those adopted by the Federal Election Commission in 2002. Therefore, any voting system deemed to be HAVA compliant must meet the 2002 voting system standards. Consequently, no new electronic voting system may be approved in Pennsylvania without meeting the high standards of the Federal government, including “second chance voting,” accessibility standards for individuals with disabilities, error rate, and audit capacity requirements”.*

The Division spent \$250,560.00 for this category. The Department made an advanced payment to Philadelphia county for the update of their voting system.

Summary

In 2003, Pennsylvania received \$35,992,863.00 under HAVA Title II, Section 251. For the 2004-2005 fiscal year the Commonwealth spent \$10,166,601.48.
