Activities Funded to Meet HAVA Requirements

In 2004 South Dakota actively prepared for the November 2 General Election. We used HAVA funding on many different projects for the 2004 election cycle. On January 1, 2004, South Dakota unveiled our statewide voter registration database. A majority of the funding to pay for the database came out of the 03 fiscal year, but any changes and improvements made to the database after January 1 was paid for in 04.

Three counties updated their punchcard equipment in 2004. The counties went with ES&S Optical Scan Systems. These counties were the last ones to get rid of their punchcard systems.

Secretary of State Nelson launched an aggressive voting education campaign educating voters on voting procedures, voting rights, and voting technology. He traveled South Dakota starting in March until the June Primary talking to service organizations, clubs, and the media. In August he hit the road again making the circuit to educate voters for the November General Election. Secretary Nelson's expenses to educate South Dakota voters were paid in the 04 fiscal year.

In September of 2004, the Secretary of State office and Kid's Voting joined forces to help register voters. Nearly 81,000 Dear Parent letters were sent home with school age children, (Kindergarten through twelfth grade) encouraging the parents to register to vote and take their children with them to vote on election day. South Dakota auditors commented that they received many of these registrations in their offices.

Also in September a mailing was sent out to nearly 250 – 300 business and organizations on voting changes in 2004. This flyer was posted in many business throughout the state to educate workers and patrons of the business on the voting changes those individuals would encounter when going to the polls.

To improve poll worker training, the Secretary of State office designed the Polling Place Voter Key. You can view this key at www.sdsos.gov/Auditors/PollingPlaceKey.pdf. The key was given to all the poll workers in South Dakota for the General Election. The key was designed to get a voter through the process to get their ballot. The poll workers loved the key. At first it looked confusing to them but in their words it gave them "confidence" to do their jobs on election day.

How Activities Conform to State Plan

The business mailing and Secretary of State Nelson's voter education campaign were keys to help South Dakota establish a voter education program on the effect of casting multiple votes for an office and how to correct ballot errors.

The mailing, educational tour, Kids Voting project and the Poll Worker Voter Key were activities that improved the administration of elections according to our state plan.

South Dakota's state plan addressed the creation and improvement of our statewide voter registration database and 04 funds were spent on this project and the plan addressed the replacement of county punchcard systems.
