On January 18, 2007, my office spoke to Edgardo Cortes regarding the January 10, 2007, letter which concerns amending HAVA Reports, Title I, Section 102 for Calendar years 2004 and 2005.

Tennessee did not spend Title I, Section 102 money in either 2004 or 2005. Mr. Cortes reviewed the files and informed me that the letter was sent in error but that the Title I Section 101 report covering the period of April 23, 2003 to December 31, 2003, did not contain a narrative and therefore needed to be amended.




