Report on Expenditure of HAVA Title II, Section 251 Funds
October 1, 2004 – September 30, 2005

The State of Utah expended no federal funds during the reporting period. However, it did apply state matching funds toward costs of developing the statewide voter registration database.

Statewide Voter Registration Database

The Utah State Plan on Election Reform as amended November 8, 2004, describes the statewide voter registration database on pages 1 and 4. The Office of the Lieutenant Governor used state funds to reimburse the Information Technology Team in the Governor's Office of Planning and Budget for expenses related to developing Utah's statewide voter registration database. These expenses include purchasing hardware, contracting with firms to convert county data to the new state format, and continuing to employ the new employee hired to implement the new system and train county election officials in its use. Expenses during the reporting period totaled \$121,445.

Interest Accrued

During this reporting period The State of Utah deposited its Title II, Section 251 funds in a Public Treasurers' Investment Fund account maintained by the Utah State Treasurer. The accrued interest totaled \$387,873.

State agencies may not earn interest on state funds appropriated for the agency's use.

State Matching Funds

State matching funds paid for all expenses during this reporting period. Expenses totaled \$121,445.

Maintenance of Effort

The State Fiscal year begins 1 July and runs through 30 June.


Total Office of the Lieutenant Governor non-HAVA expenses for State Fiscal Year 2005 was \$813,428.
