**West Virginia's  
2004 Section 101 Expenditures  
As Amended**

West Virginia received a total of \$2,977,057.00 under Title I Section 101 of the Help America Vote Act. To date the amount of interest accrued for this section is \$6,185.49 for a total amount available of \$2,986,242.40. Section 101 allows for states to utilize this funding for a variety of uses including but not limited to improving the administration of elections, training election officials, replacement of voting systems, upgrading precinct accessibility, and the implementation of Title III of HAVA.

In order to continue implementation of the Statewide Voter Registration System, payments to the vendor during this reporting period were addressed. The total contracted to PCC Technology Group LLC for the provided system was approximately \$2.4 million. Payments were made in accordance with the contract and defined milestones. Additional expenses were realized for this project due to the transfer of data to the new software from the previous voter registration system in each county. Further expenses were addressed upon determining that the current structure of the state network was inadequate to handle the data transfer that would occur in utilizing the voter registration system. The state's division of computer services, Information Services and Communications, provided the initial and continual administration of the network used to serve each county.

Each expenditure provided for by Section 101 of HAVA for the current reporting cycle is reflected in the following chart:

In addition to the expenses of the voter registration system, Section 101 funds were used to provide additional personal services for the implementation of HAVA. The Elections Division for the state consisted of a Team Leader, one campaign finance specialist, one election assistant and one part-time individual. In order to efficiently implement HAVA the duties of the election assistant were adjusted to include the implementation and support of the voter registration system. The adjusted position became responsible for the training of county officials on the new system and to work with the HAVA director and the vendor to finalize implementation and prepare the counties for a successful first election. The remainder of the expenses found within the current reporting cycle for Section 101 were used to supplement the accessibility program created under HAVA. These expenses were reimbursed through the funding received from Section 261 of HAVA.

As West Virginia continues to implement the state plan, it is anticipated that large expenditures will be made to upgrade the voting equipment across the state and to comply with the other requirements of HAVA.
