These funds are being used to carry out activities to improve the administration of elections for federal office previously covered with 101 funds that are now exhausted. General administrative expenses included salaries, benefits, retirement, and training expenses for employees paid with HAVA funds, telephone expenses, and maintaining geographic information system (GIS) tools in conjunction with another state agency to provide a voter lookup website, including absentee by mail ballot tracking. These funds also support the continued implementation of online voter registration, and work was completed in this fiscal year to upgrade the statewide voter registration database. During this reporting period, the office employed an AES system administrator and a HAVA attorney. The system administrator continues to maintain the voter registration database, as well as provide support to local election officials. The HAVA attorney supervises the implementation of requirements set forth in the Act. This includes working with the system administrator, working with administrators of elections, and local election commissions with regard to voting systems, overseeing the distribution of HAVA funds, reviewing contracts, and training election officials. In addition, the HAVA attorney assists another attorney in the office in working on accessibility issues relating to polling locations in Tennessee. These employees are responsible for the continued training of election officials regarding the Help America Vote Act requirements and the MOVE Act.
