The purpose of this letter is to certify that the District of Columbia will use the funds provided under the Notice of Grant Award, Agreement #DC18101001, for activities consistent with the laws described in Section 906 of HAVA and will not use the funds in a manner that is inconsistent with the requirements of Title III of HAVA.

We further certify that we have reviewed and accept the terms of the award as specified in the Notice of Grant Award. Our DUNS number is 611498887 and the signed Certification Regarding Lobbying is enclosed.

We are requesting \$3,000,000.00 at this time. We are developing a spending plan for this additional HAVA funding. We expect to use some of the funds for increased security to address potential cyber vulnerabilities in the management of the voter registration system. We are also seeking to retain a full-time cyber security resource dedicated to the elections infrastructure, and we will upgrade election equipment for the expansion of Early Vote Centers.

**Certification for Contracts, Grants, Loans, and Cooperative Agreements**

Any person who fails to file the required certification shall be subject to a civil penalty of not less than \$10,000 and not more than \$100,000 for each such failure.
