The State provided security training through its in-house cyber navigator team. The team also provided training at scheduled Supervisor of Elections' conferences and promoted tabletop exercises with federal and state law enforcement and security partners. These efforts furthered the initiatives to provide counties with individualized assistance and guidance regarding security topics and issues leading up to and through the 2022 Election Cycle.

The funds were made available to our grantees in the form of multiple subgrants from our Election Security grant 20-21. Award amounts were based on identified security enhancements recommended by our cyber navigators to help counties enhance cyber security. We also have our Network Failover grants which was instituted to assist counties with Florida Voter Registration System security and purchase and maintenance of failover devices monitoring hardware and software, including installation and maintenance and monitoring services.

In Florida, state agencies must first receive state authorization (legislative appropriation and executive budgetary approval) for use of federal and state funds. The delay in release of these funds compounded with the continuing supply chain disruptions, shortages, and increasing costs mean that grantees must be ever resourceful and ready to act once funds are available or be judicious in deciding whether to apply for reimbursement or advance or not applying at all.

We are working to consolidate future sub-grants so that will streamline the process. The federal Election Security Grants are critical infusion to funding Florida's strategy to support and secure elections, provide transparency, and build public trust and confidence in elections at the state and local level. The State's plan since receipt of these funds is to use the federal election security funds until exhausted to bolster the Department of State's infrastructure as needed to implement security enhancements to the Florida Voter Registration System and other election applications, to establish periodic online grant programs for 67 county supervisors of elections to apply for funding to improve their voting systems, to improve on voting accessibility which may include improving voting place accessibility, enhancing poll book accessibility, ballot delivery, and voting systems accessibility, and to identify and mitigate cyber vulnerabilities at the State and local election offices, and voting equipment and upgrades. The subgrants during this period covered by the report successfully furthered the State's ongoing plan.

The State pursuant to legislative appropriation made available for counties up to the following amounts under each of the following four grants which enhanced the election security posture at the state and local level for the 2022 election: • G1 Network Failover /\$200,000: To assist Counties with reimbursement or advance to purchase a failover device and/or service as well as explore adoption of FirstNet services for that device(s). • G2 Tabulation System/\$750,000: To assist Counties by reimbursement or advance to purchase appropriate hardware to deploy some form of security monitoring device ahead of their certified systems but behind the secure, encrypted cellular connection for unofficial results. This may include network taps to feed ALBERT sensors additional data, small firewalls with monitoring capabilities, or related hardware solutions. • G3 Private Network/\$750,000: To assist Counties to reimburse for or purchase appropriate hardware to deploy some form of next-generation firewall, intrusion prevention system, and/or zero-trust style technology. This may include network taps to feed ALBERT sensors additional data, small next-generation firewalls with monitoring capabilities, or related hardware solutions. • G4 New Election Security/\$1,500,000: To assist Counties by reimbursement or advance for purchase of goods and/or services in the following categories: o Category 1: Multi-factor Authentication (MFA) and Access Controls o Category 2: Vulnerability Management o Category 3: E-Mail Security (Including DMARC) o Category 4: Network Hygiene, Segmentation, and Security o Category 5: Endpoint Hygiene and Security o Category 6: Physical Security and Other Needs o Category 7: Elections Security Equipment
