



Voting and Turnout


Voters Participating By Mode⁶

- 61,460,139 mail ballots transmitted11
- 59.7% of transmitted mail ballots returned by voters12
- 97.4% of returned mail ballots counted¹³
- 1.5% of returned mail ballots rejected 14
