### **EAC Clearinghouse Network Disclaimer**

You are accessing the EAC Clearinghouse Network. Your usage of the EAC Clearinghouse Network may be monitored, recorded, and subject to audit. The EAC Clearinghouse Network may be used only by authorized users for authorized purposes. Unauthorized access and use are prohibited and subject to criminal and civil penalties. Use of the EAC Clearinghouse Network indicates consent to monitoring and recording.

The EAC Clearinghouse Network is maintained by the U.S. Government and is designed to comply with federal laws of the United States. It is protected by various provisions of Title 18, United States Code, Section 1030, and other federal or state criminal and civil laws.
