Voting Equipment	\$306,788.10	\$19,881.56	During this reporting period grant funds continued to support AT&T's FirstNet connectivity services for the voting equipment. FirstNet service helped to ensure we could receive results transmissions timely by giving the division priority service on election night should there have been congestion issues on the network. Transmitting results in this manner is part of the division's security protocols. Funds were also expended for the annual licensing and maintenance costs for the voting equipment as well as parts and repairs costs. No additional voting machines were purchased during this period. Overall expenses for the voting equipment category equaled \$326,669.66 (federal share \$306,788.10; state share \$19,881.56).
Voting Processes	\$4,142.48	\$218.03	During this reporting period, funds were expended with Carahsoft Technologies for communications software licensing for communications between elections offices during the election cycle.

Cyber Security	\$133,658.20	\$98,220.70	During this reporting period grant, the division provided all division offices with contact information for law-enforcement support for the October 2022 Regional Attendance Area Elections and the November 2022 General Election. In addition, the division continued to monitor emails received from the division offices for any suspicious behavior or physical threat to an office. The division has remained diligent on physical security concerns and completed the final office walk-throughs with the representative from the Department of Homeland Security in October and November 2022, and in March 2023. The division is anticipating all final reports and has started to discuss physical buildouts to office reception areas that need further hardening in preparation of the 2024 election cycle. In October, the division completed installation of CCTV video monitoring in the Nome office. All offices now operate with CCTV monitoring; however, the solution implemented has some drawbacks, chiefly the ability to fetch and transmit data should an incident occur. The division will be exploring other solutions during this next year. In March 2023 the division completed an internal and external penetration test of the voter registration environment. The executive summary with recommendation was reviewed by senior leadership and forwarded on to the managed service

			vendor for review and implementation. Also in March 2023, the division
			contracted with a vendor to provide a Discovery, Planning, and Design roadmap for migrating the voter registration environment into the Azure Cloud. Overall expenses attributed to the election security category, cyber and physical, were \$231,878.90 (federal share principal \$133,658.20; state share principal \$98,220.70). Personnel expenses for the election security personnel equaled \$213,198.88 (\$106,599.44 federal share principal, \$106,599.44 state match principal). Other associated support cost for items such as contractors, business supplies, equipment, and services were \$49,313.02 (\$27,058.76 federal share principal, -\$8,378.74 state match principal).
Physical Security			Figures for cyber and physical security for this period were combined in the cyber security category. During this reporting period grant, the division provided all division offices with contact information for lawenforcement support for the October 2022 Regional Attendance Area Elections and the November 2022 General Election. In addition, the division continued to monitor emails received from the division offices for any suspicious behavior or physical threat to an office. The division has remained diligent on physical security concerns and completed the final office walk-throughs with the representative from the Department of Homeland Security in October and November 2022, and in March 2023. The division received the final reports, and regional offices are implementing some of the recommendations including additional physical hardening and access control as well as installing intercoms and window protection. In October, the division completed installation of CCTV video monitoring in the Nome office. All offices now operate with CCTV monitoring; however, the solution implemented has some drawbacks, chiefly the ability to fetch and transmit data should an incident occur. The Division is exploring a new cloud-based option that will eliminate the issue.
Voter Education	\$1,286.24	\$67.70	During this grant reporting period, the Public Relations Manager focused on educating the public about the security measures the division takes to ensure fair and accurate elections and communicated with the public to mitigate mis/disinformation regarding election security. The Division held a General Election on November 8 which heavily increased the number of concerns and inquiries from the media and the public about election security, especially in the weeks following election day when ballots were being counted. Alaska implemented a new voting system in 2022 called Ranked Choice Voting that required voters to rank candidates in order of preference. This system was vastly different than anything voters had seen before, and with most change, different can sometimes invoke mistrust and apprehension. This was especially true for the ranked choice results tabulation and the software and equipment we use to perform it. To help mitigate concerns and mis/dis-information, the PR Manager decided to provide a live statewide broadcast/stream of round-by-round results tabulation so the public could see how the software worked. We partnered with a local public media outlet and planning for the event began in October. During production planning, our main priority was ensuring the integrity of our tabulation software and equipment by keeping it secure and figuring out ways for cameras and microphones to film the screens without being connected to any equipment. These security precautions were communicated to voters in the weeks leading up to the event and during the tabulation itself. Much of the remaining time during this grant period was spent continuing to educate voters about the integrity of the software/equipment, the processes, and the accuracy of the results. Expenses for the communications/voter education category equaled \$1,353.94 (federal share principal \$1,286.24; state share principal \$67.70).

TRAINING

During the reporting period: the Election Security Officer completed training in Digital Forensics Essentials and Cyber Vulnerability Assessments, Certified Vulnerability Assessor, and Certified Professional Ethical Hacker. Additionally, the ESO attended the Cyber Resiliency conference in Anchorage in April and the EI-ISAC conference in August. Expenses for the training equaled \$10,860.00 (federal share \$5430); state share \$5430).

Match for the series of awards was met through four separate appropriations from the state. A first match of \$1,626,612 in general funds was appropriated in FY19 to the Election Fund as a result of a reappropriation in Ch. 19, SLA 2018, Sec. 15(b). A second match of \$600,000 in general funds was appropriated in 2020 to the Election Fund in HB 234, Section 19 (a); SB 174, Section 19 (a). A third match of \$200,000 in general funds was appropriated in 2022 to the Election Fund in HB 281, Section 27 (h) line 3. A fourth match of \$200,000 in general funds was appropriated in 2023 to the Election Fund in Alaska House Bill 39, Section 14, page 89, line 25; and Section 71(t), line 9.
