TRAINING

California counties were reimbursed for cyber security contracts that were provided to California's 58 counties in prior reporting periods. Under these contracts, counties are allowed to submit claims for reimbursement for the implementation of cyber security safeguards and associated infrastructure enhancements to protect against cyber risks and vulnerabilities. As a condition of receiving funds under the contract, counties must conduct a security assessment and conduct security awareness training for all staff. Training must include cyber security best practices, including how to recognize a phishing email, creating and maintaining strong passwords, utilizing multi-factor authentication, and avoiding dangerous applications. HAVA staff ensured that for any claims of reimbursement during the reporting period, the appropriate cyber security training took place during review of the claims for reimbursement. In addition, polling place accessibility training of counties on accessibility requirements and mitigations was provided to California's 58 counties.
