During the reporting period, the Department expended \$116.00 in Election Security Grant funds to conduct the Cybersecurity & Infrastructure Security Agency (CISA) Tabletop the Vote is a yearly event with Department of Homeland Security (DHS), Federal Bureau of Investigations (FBI), Colorado National Guard and Attorney General's (AG) office to prepare for unexpected or malicious activity that may happen during the upcoming 2024 election cycle. This year over 75 individuals from local, state, and federal organizations discussed appropriate responses for different scenarios. During the reporting period, the Department expended \$27,045.42 in Election Security Grant funds to pay for materials and travel costs for the 2024 EPIC training6. The Department held the first tabletop exercises in January of 2019, creating real-life security situations requiring immediate response and has continued to hold EPIC trainings during the spring of even years, that build on the first event. The Department conducted the fourth EPIC in 2024. The six day-long sessions included county election, IT, and comms officials, as well as local, state, and federal cross-sector partners. The sessions included updated situations involving possible scenarios that could occur leading up to and including election day. Not only did individuals work on how to resolve these situations but also realize how each event impacted other areas involved with the election. In total, the sessions included 454 participants, 12 trusted partners (CISA, FBI, DHS), and 12 facilitators. The Department also conducted a half-day mini-EPIC in coordination with the county association conference that featured AI scenarios. During the reporting period, the Department expended \$12,300.00 of Election Security Grant Match funds to pay for online training to build security awareness among election officials and poll workers on how to recognize and report suspicious activity in order to prevent targeted violence, terrorism, and criminal acts. The Department partnered with Counter Extremism Learning Lab (CELL) is an organization that specializes in building and tailoring this type of training and has been accredited with the SAFETY Act Certification. The CELL built a robust community awareness training program that was created in partnership with the U.S. Department of Homeland Security (DHS) and the FBI's Joint Terrorism Task Force.

In direct response to the increased threats to American election systems. The improvements included items such as upgrading security camera systems, network security and upgrades to elections IT systems. 2) Sub-Grants to purchase new ICX Printers- During the reporting period, the Department expended \$300,122.77 in Election Security Grant funds to assist the county in the purchase of printers to use with their Dominion ImageCast X (ICX) ballot marking device. The purchase of these printers for counties improves the administration of federal elections by removing the QR code from ICX ballots and instead produces an ICX ballot that is virtually indistinguishable from a mail ballot. Acquisition of the new printer will give counties the option to use ballot cards larger than 14 inches which will be significant for federal elections.
