- 1. Documentation was removed for instructions that had the user copying the Vanguard folder structure from the workstation and then hashing with COTS hardware and software.
- 2. Documentation was added for utilizing the workstation's operating system SHA256 algorithm to hash and store each Vanguard ".exe" and ".dll" within a file named "hash-export.csv", which can be used for verifying the hashes.

As required under section 3.5.1 of the EAC's Voting System Testing and Certification Program Manual Version 3.0, SLI Compliance considers the nature of ECO-01720 to be minor and therefore not to affect the Federal certification status for the Verity Vanguard 1.0 system. No additional testing is required.
