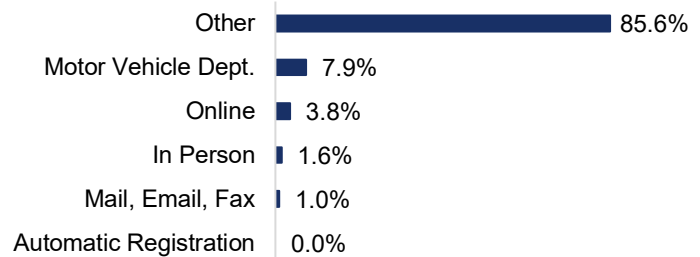

Iowa was unable to report complete data on voter participation by mode in the 2024 EAVS.<sup>6</sup>

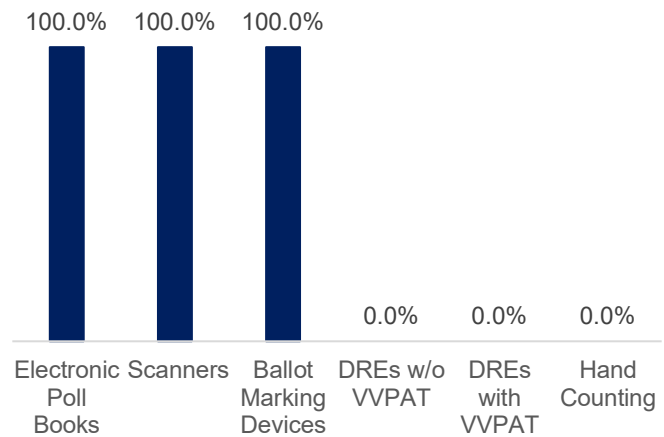
