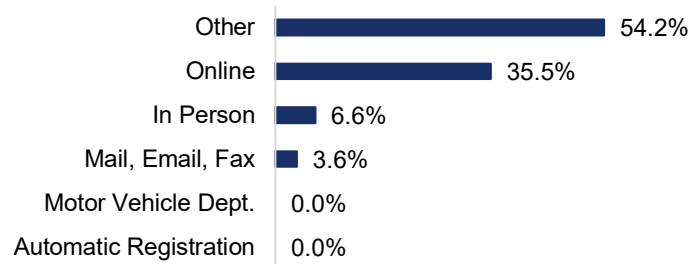




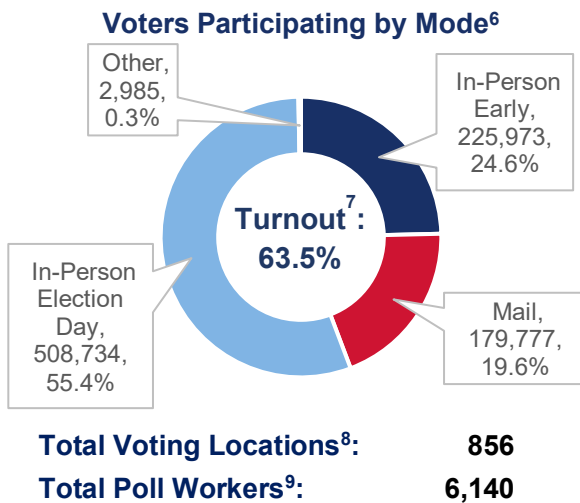

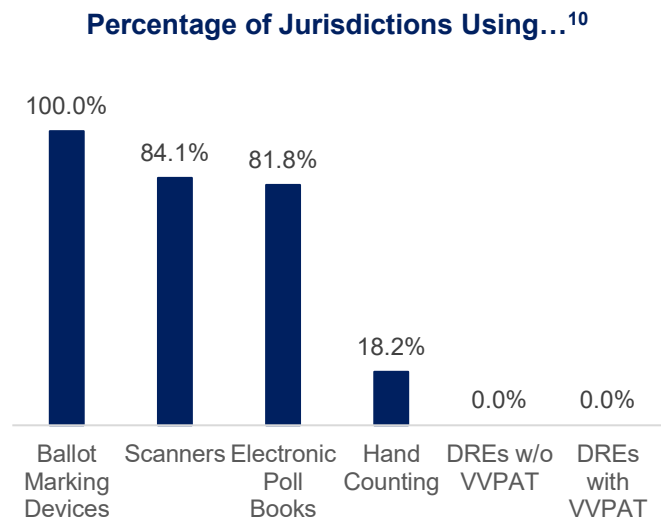
### Source of Registration Transactions<sup>5</sup>
