

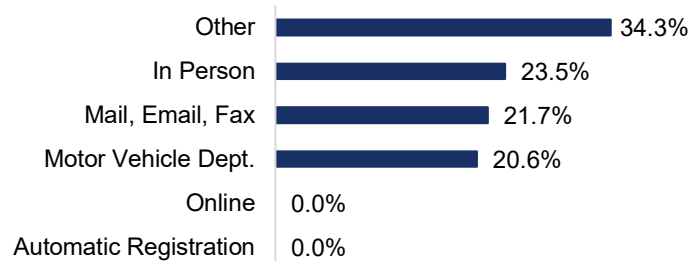


# 2024 EAVS Data Brief Montana

### Source of Registration Transactions<sup>5</sup>



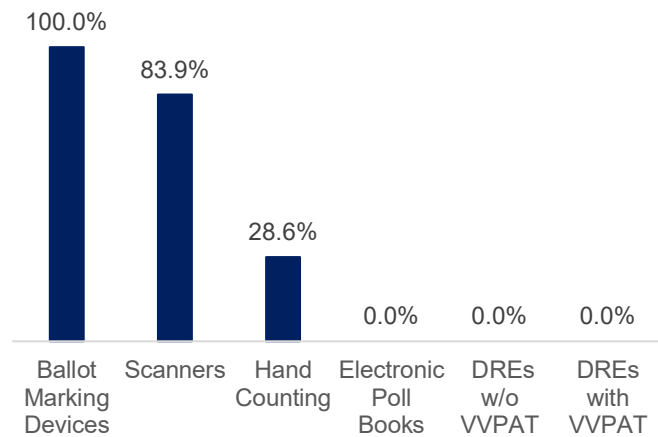
## Voting and Turnout

Montana was unable to report data on voter participation by mode in the 2024 EAVS.<sup>6</sup>

## Mail Voting

**503,295** mail ballots transmitted<sup>11</sup>  
**85.9%** of transmitted mail ballots returned by voters<sup>12</sup>  
**99.5%** of returned mail ballots counted<sup>13</sup>  
 Did not allow drop boxes<sup>14</sup>  
**2.4%** of mail ballots entered ballot curing process<sup>15</sup>
