

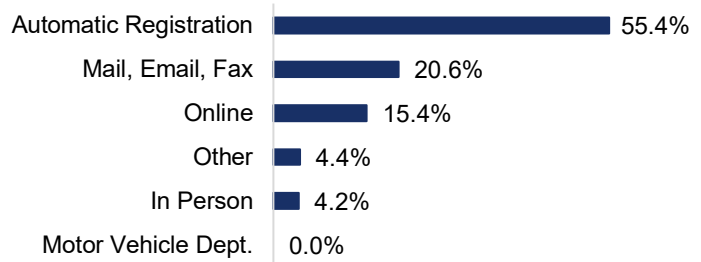

## Voter Registration

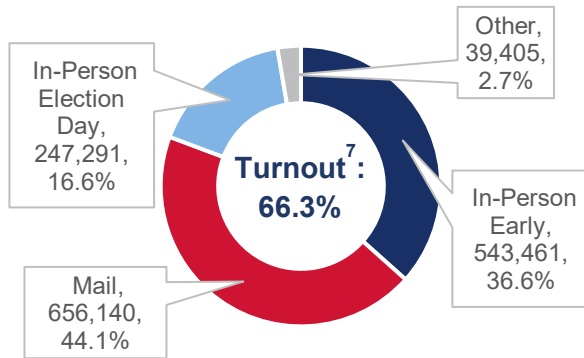

## Mail Voting

**2,069,339** mail ballots transmitted<sup>11</sup>  
**32.4%** of transmitted mail ballots returned by voters<sup>12</sup>  
**98.0%** of returned mail ballots counted<sup>13</sup>  
**44.8%** of mail ballots returned at drop boxes<sup>14</sup>  
**4.9%** of mail ballots entered ballot curing process<sup>15</sup>
