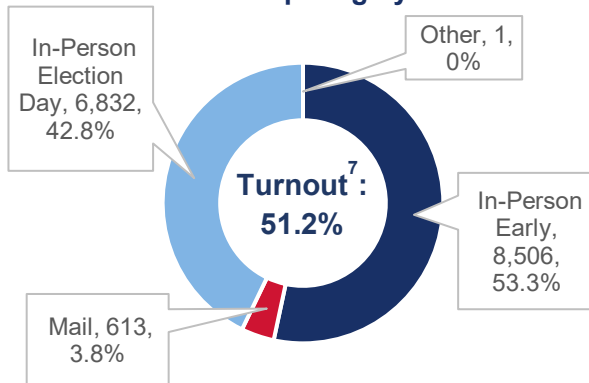

### Voters Participating by Mode<sup>6</sup>

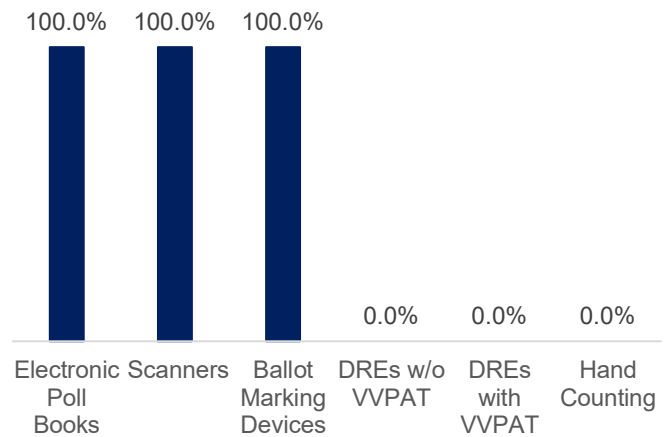
