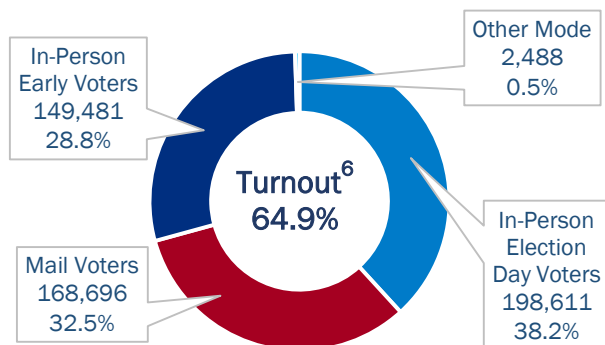

### Voters Participating By Mode<sup>5</sup>

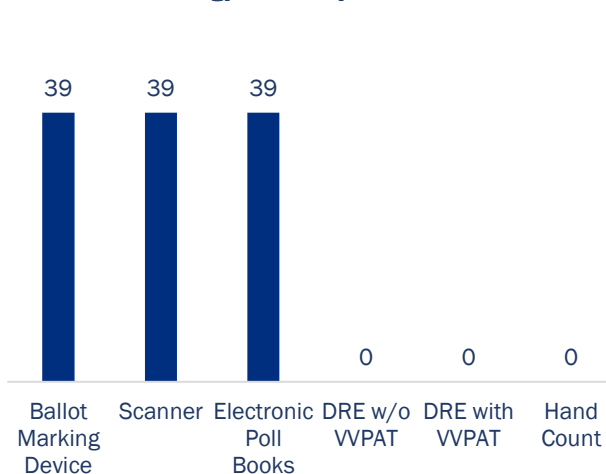
