BRIANNA SCHLETZ NAMED EAC INSPECTOR GENERAL

The EAC announced that Brianna Schletz has been named as our next Inspector General. Brianna joins the EAC after eight years at the Office of Inspector General at the U.S. Agency for International Development (USAID) where she most recently served as a director and established a new strategic division within the Immediate Office. During her time at USAID, Brianna led a team of program analysts responsible for congressionally mandated quarterly reporting and oversight planning on overseas contingency operations as well as conducting audits, evaluations and reporting on significant issues affecting agency operations. OCTOBER 13, 2021 TGDC MEETING

On October 13 the Technical Guidelines Development Committee (TGDC) held a virtual meeting to discuss the implementation of the VVSG 2.0, the VVSG Lifecycle Policy, and a process to evaluate and approve protocols for End-to-End (E2E) verifiable voting systems. - <u>VVSG Lifecycle Policy</u> The Lifecycle Policy for VVSG 2.0 will be opening soon for the public comment period. Updates will be posted to <u>our website</u> once the comment period opens.
- <u>ePollbook Pilot Program</u> The EAC is currently developing draft security requirements covering a variety of topics such as access control, software security, audit records and more. Next steps include drafting accessibility and usability requirements, drafting program documents, gathering feedback, and test piloting.

HAVA TURNS 19

On October 29, the EAC will celebrate the 19th anniversary of the Help America Vote Act (HAVA). Congress passed HAVA in 2002 to set new mandatory minimum standards for states to follow in several key areas of election administration and to invest in and strengthen the nation's voting process. HAVA also created the Election Assistance Commission to help ensure secure, accurate, and accessible elections by developing guidance to meet HAVA requirements, adopting voluntary voting system guidelines, and serving as a national clearinghouse of information on election administration. The EAC also accredits testing laboratories, certifies voting systems, and administers HAVA funds. For the last 19 years, HAVA and the EAC, have provided state and local election officials with resources and guidance to ensure all Americans can participate fully in the voting process, and cast a ballot privately and independently.
