



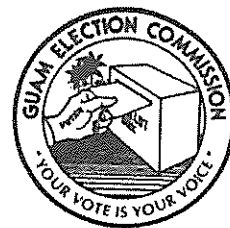

In preparing the state plan and in preparation for Guam HAVA State Plan Development & Coordinating meetings, GEC purchased necessary supplies. Such supplies included materials for several committee meetings that occurred between July 2003 through September 2003 which had a total of 24 participants ranging from GEC's board members, party chairs, mayors from major districts, representatives from the University of Guam Center for Excellence in Development Disabilities Education, Research, and Services, the Department of Integrated Services for Individuals with Disabilities, and also representative from the disabled communities. With the aide from the committee the GEC developed, revised, and finalized a state plan, which was then forward to the Election Assistance Commission. Also included were advertisements to the public regarding the committee's meeting to discuss and develop a state plan. GEC also began the process of modifying its current office to ensure that it was easily accessible to all eligible voters.</p> <p>Also included in this category were payments towards our Legal Counsel for his review and assistance in the development of the State Plan.</p>	\$29,156.46
§301 Voting System Improvements	The GEC used early monies to set up and develop a website. The websites main purpose is for overseas voters to have access to information regarding any Guam election matters and to contact the GEC. Overseas voters have access to necessary forms to request for absentee ballots, access to information regarding elections results, access to GEC's general information and HAVA information.	\$2,539.00
§303 Computerized statewide voter registration list requirements and requirements for voters who register by mail.	The GEC used early monies to educate the Information and Technology Manager and the Program Coordinator who will be primarily responsible for developing and completing the centralized voter registration system and linking it to the necessary government agencies to comply with HAVA regulations.	\$11,857.00
Personnel Cost to Include Benefits	The GEC incurred personnel cost in the following areas: (1) Researching and drafting a state plan to present to the Guam HAVA State Plan Development & Coordinating panel; (2) Preparation for the Guam HAVA State Plan Development & Coordinating meetings which spanned between July 2003 through September 2003; and (3) Researching and drafting a strategic plan for the acquisition and implementation of a computerized voter statewide registration system.	\$9,723.58
