The momentum to modernize the Voluntary Voting System Guidelines continued this month when the newly designated members of the Technical Guidelines Development Committee gathered together in Gaithersburg, Maryland.

During two days of meetings in the “Portrait Room” at the National Institute of Standards at Technology (NIST) building, the TGDC members heard presentations from distinguished experts concerning various aspects of voting system development and certification. Those topics will be discussed in greater detail later in this newsletter.

But first, we should take a moment to celebrate a great accomplishment: we have now completed the organizational phase of our work together and have moved forward into development!

Each of the four entities created by HAVA (the U.S. Election Assistance Commission, the Board of Advisors, the Standards Board, and now TGDC) has been revived, reorganized, and is functioning. The foundation has been laid for the more painstaking work that lies ahead: a review of the current VVSG, and the adoption of a new VVSG to address voting system issues in the years ahead.

It will be a lengthy journey, but one that offers the opportunity to increase public confidence in the accuracy, integrity, and reliability of our voting systems. Let’s enjoy the ride!



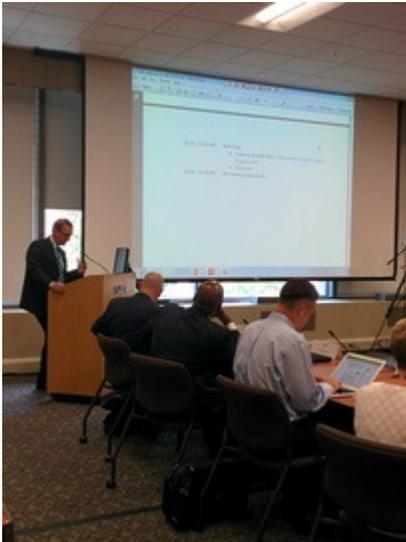

TGDC Meets in Gaithersburg to Begin its VVSG Work

On July 20-21, 2015, the TGDC convened for the first time in several years. Greg Riddlemoser, Standards Board representative to the TGDC, described the recent meeting as “very productive”, and remarked that it was encouraging for him to see “really smart people working really hard to solve really hard problems!”

The TGDC’s agenda began with opening remarks by Dr. Willie E. May, chair of NIST, and Commissioner Matt Masterson, the Designated Federal Officer for the TGDC.

EAC staff presented information on EAC goals and the VVSG 1.1 update, while representatives from the Bipartisan Policy Center and representatives from NASED, the Standards Board, the Board of Advisors, and the Federal Voting Assistance Program provided their viewpoints and recommendations regarding the process. Speakers presented the “voters’ perspective” on usability and accessibility, while Merle King of the Center for Election

Systems at Kennesaw State University discussed state certification needs. NIST staff, including Mary Brady, Manager of NIST Voting Program, offered information on the status of standards development, on EAC accessibility grants, system security, and system interoperability. David Becker of the PEW Charitable Trusts spoke regarding data sharing programs such as the Voting Information Project and ERIC.

These presentations prompted extended strategy discussions about how best to proceed with the revision of the VVSG.

Although a date has not yet been set for the next TGDC meeting, early December 2015 is a possibility.

Standards Board Executive Board Meets July 16; Finalizes NIST Letter

During its monthly conference call, the Executive Board received updates from Board members and our Designated Federal Officer. In addition to receiving reports concerning the VVSG Committee and the Bylaws, the Executive Board had a thorough discussion of a draft letter to be sent to Dr. May, the Director of NIST. The letter expressed appreciation for the involvement of NIST in the development of previous voting system standards with the TGDC, and for NIST making appointments promptly to revitalize the TGDC.

The letter also stressed that the TGDC should include non-governmental partners to “improve the speed and accuracy” of the work on the VVSG revision. The letter also expressed the need for “the broadest input possible from voting system vendors”, noting that while “we know that they have a vested interest in what standards they will be asked to meet when creating the next generation of voting systems”, that by the same token, “all of the stakeholders have their own interests, and the broader the participation in the process creating them the better the standards will be.”

The letter urged NIST to “maintain a strong partnership with the EAC and its advisory boards”, and to leverage the EAC’s relationships with the election community when NIST provides technical advice to the TGDC.

The Executive Board’s conversation then turned to the EAC Clearinghouse. Members recalled the extensive discussion of the work and focus of the Clearinghouse during the Williamsburg meeting, and created an “EAC Clearinghouse Committee” of the Standards Board to provide input to the EAC regarding the scope and operations of the Clearinghouse. The Board decided to invite the membership to indicate if they would be interested in serving on this committee.

The Board finished its meeting after receiving a report from EAC Chairwoman Christy McCormick on the upcoming EAC Data Summit, and planned to meet again in August.

Bylaws Committee

Five Proposed Bylaws Amendments Received

As of the July 15, 2015 submission deadline, five proposed amendments to the Standards Board Bylaws were received by the Designated Federal Officer, EAC Chairwoman Christy McCormick. Each of these amendments could be described as either technical in nature, or addressing some of the mechanics of the work of the Standards Board. For example, the amendments would update references to our new 2015 federal charter, correct mistaken cross-references within the Bylaws, specify the method and schedule to be used to fill mid-term vacancies on the Executive Board, and clarify the role of the parliamentarian at Standards Board meetings.

The next steps will be for the Bylaws Committee to receive and review a report from the EAC General Counsel regarding whether or not any proposed change to the Bylaws is consistent with federal law, and then for the Committee to transmit a report concerning the proposals to the Executive Board. The Executive Board will then

place the report concerning proposed Bylaws amendments on the agenda for the next meeting of the full Standards Board, and give written notice of the proposed changes to the entire membership by email and US mail, as well as posting the proposed amendments on the EAC's website at least 30 days before the next Standards Board meeting.

Voluntary Voting Systems Guidelines (VVSG) Committee

On July 20-21, 2015, the TGDC convened for the first time in several years. Greg Riddlemoser, Standards Board representative to the TGDC, described the recent meeting as "very productive", and remarked that it was encouraging for him to see "really smart people working really hard to solve really hard problems!"

Technically, this gathering was a "pre-meeting" pending finalization of the appointments of some TGDC members. The TGDC's agenda began with opening remarks by Dr. Willie E. May, chair of NIST, and Commissioner Matt Masterson, the Designated Federal Officer for the TGDC.

EAC staff presented information on EAC goals and the VVSG 1.1 update, while representatives from the Bipartisan Policy Center and representatives from NASED, the Standards Board, the Board of Advisors, and the Federal Voting Assistance Program provided their viewpoints and recommendations regarding the process. Speakers presented the "voters' perspective" on usability and accessibility, while Merle King of the Center for Election Systems at Kennesaw State University discussed state certification needs. NIST staff, including Mary Brady, Manager of NIST Voting Program, offered information on the status of standards development, on EAC accessibility grants, system security, and system interoperability. David Becker of the PEW Charitable Trusts spoke regarding data sharing programs such as the Voting Information Project and ERIC.

These presentations prompted extended strategy discussions about how best to proceed with the revision of the VVSG. Bob Giles explained that the TGDC will use public working groups to take a different approach to the next version of the TGDC. Under this process, the TGDC will develop a three-part document, consisting first of "plain language" Principles to enunciate the core values of the Guidelines. The next part, more detailed Standards for voting equipment, will be linked to specific Principles. The final part, the Testing Assertions, will be derived from the general Principles and the more detailed Standards. This structure is designed to tie the three parts of the new VVSG together, and to provide better tools for ensuring that each part of the VVSG is consistent and comprehensive, and does not include unnecessary text or unfocused requirements.

TGDC members are planning to meet again in early December 2015.

US EAC Data Summit

On Wednesday, August 12 and Thursday, August 13, the EAC will convene a “Data Summit” of election researchers, state and local election officials, and representatives from non-profit election organizations at American University in Washington. The goal of the summit is to identify “How Data Can Help Elections Run Better.” The topics for discussion at the Summit will include the accuracy, usefulness, and standardization of election data, and practical applications for the election data currently collected. The Summit will also focus on planning for the 2016 Election Administration and Voting Survey (EAVS), and strategic planning for future EAVS surveys.

It is important for the state and local government members of the Standards Board to have a voice in this ongoing discussion. At the next Executive Board meeting, we will receive a report regarding the Data Summit and consider how best to ensure that we are involved in shaping the future of EAVS.

The Executive Board certainly appreciates that one or more states will have primaries or caucuses which will fall too close to some dates to make it easy (or even possible) for members from those states to attend the Standards Board meeting.

We encourage you to continue to give your input on possible meeting dates (October 2015; January 2016; April 2016) to help with the preparations that must be completed before any meeting is called. As noted in the last newsletter, there are concerns about funding uncertainties at the beginning of the next federal fiscal year (October 1, 2015) and winter weather which make it difficult to plan with confidence in assuming that a specific date will be practical.

EAC staff are continuing to research hotel rates and capacity, air fares and routes, and a variety of other factors which must be considered in scheduling this meeting, regardless of the date. We will keep you informed as news becomes available.
