This letter is notice that Colorado plans to use the funds provided under the Notice of Grant Award, Agreement # CO18101001, for activities consistent with the laws described in Section 906 of HAVA. Further, Colorado will not use the funds in a manner that is inconsistent with the requirements of Title III of HAVA.

**Certification for Contracts, Grants, Loans, and Cooperative Agreements**
