November 8, 2018 – 6:15 AM

- Fire was ignited in a remote area of Butte County
- "Camp Fire" was driven North West by intense winds in areas of high fuel loads
- Moving from ridge to ridge, in less than 12 hours fire burned through communities of Concow, Paradise, Magalia, and Butte Creek Canyon.



BY END OF DAY:

• 46,000 people had to be evacuated from their home

Before it was ultimately contained on November 25, 2018:


- 153,336 acres were consumed
- Destroyed 18,793 structures
- Damaged another 664 structures
- Resulted in the deaths of 85 people





- To date the "Camp Fire" is the deadliest and most destructive fire in the history of the State of California.
- The sixth deadliest wildfire in the history of the United States and the world's costliest natural disaster in 2018.

California Election Code Sections Define Residence and Domicile

EC 349. "Residence" and "Domicile" definition.

- "Residence" for the voting purposes means a person's domicile.
- The domicile of a person is that place in which his or her habitation is fixed, wherein the person has the <u>intention of remaining</u>, and to which, whenever he or she is absent, the person has the <u>intention of returning</u>. At a given time, a person may have only one domicile
- The residence of a person is that place in which the person's habitation fixed for some period of time, but wherein he or she does <u>not have the intention</u> <u>of remaining</u>. At a given time, a person may have more than one residence.

California Election Code Sections Define Residence and Domicile

EC 2021. Person away for temporary purposes.

- A person who leaves his or her home to go into another state or precinct in this state for temporary purposes merely, with the intention of returning, does not lose his or her domicile.
- A person does not gain a domicile in any precinct into which he or she comes for a temporary purposes merely, without the intention of making that precinct his or her home.

California Election Code Sections Define Residence and Domicile

EC 2022. Move to another state.

• If a person moves to another state with the <u>intention of</u> <u>making it his or her domicile</u>, the voter loses his or her domicile in the state.

"It is important to note, the reliance on intention".

ELECTIONS OFFICE IS URGING VOTERS DISPLACED BY THE CAMP FIRE TO UPDATE VOTER REGISTRATION INFORMATION

OROVILLE, CA – Butte County Clerk-Recorder/Registrar of Voters, Candace J. Grubbs, is urging residents displaced by the November 2018 Camp Fire to update their mailing address with the Registrar of Voters so that they will receive important election materials for upcoming elections.

"We want to help voters who may have been impacted by the Camp Fire understand how to update their voter registration. Options will depend greatly on what the voter's intent is," said Candace J. Grubbs, Butte County Clerk-Recorder/Registrar of Voters.

Voters who intend to return to their properties may retain the impacted residence address in order to continue to vote in their original precinct, but will need to update their temporary mailing address on their registration. Voters who do not intend to return to their impacted property address should re-register at their new permanent residence address.

Voter Registration Fact Sheet for Voters Affected by the Camp Fire

When voting, your <u>residence address</u> determines the contests that appear on your official ballot. Your <u>mailing</u> <u>address</u> is where we mail your voting materials, which is important because election mail cannot be forwarded to you, it is returned back to us. You may only be legally registered in <u>one county</u>.

See below for situations and actions to take regarding your Voter Registration.

- I. Displaced Voters who intend to rebuild and return to affected address If you have temporarily moved, but plan to return, you can continue to use the address of your fire affected property for voting. Give us your mailing address so you continue to receive election mail. If you are not already voting by mail, you may wish to sign up and receive a ballot in the mail for future elections.

 - You need to change your address. You may do this in one of the following ways:

 - In person, County Clerk-Recorder Hall of Records, 155 Nelson Avenue, Oroville
- 3. Displaced Voters who have not decided on whether to return or move

If you have not made a decision at this time, you can continue to use the address of your fire damaged property for voting. Give us your mailing address so you continue to receive election mail. If you are not already voting by mail, you may wish to sign up and receive a ballot in the mail for future elections.

When you decide whether you will stay or leave, update your Voter Registration record at that time.

Address information has been received from several sources that indicates you may have a different residence and/or mailing address.

When voting, your <u>residence address</u> determines the contests you are eligible to vote on. Your <u>mailing address</u> is where we mail your voting materials, which is important because election mail cannot be forwarded to you, it is returned back to us. You may only be legally registered in <u>one county</u>.

Review information below to determine the situation that best fits you and complete and return the attached card.

1. Displaced Voters who intend to rebuild and return to affected address

If you have temporarily moved, but plan to return, you can continue to use the address of your fire affected property for voting. Complete section 1 on the attached card to give us your new mailing address.

2. Displaced Voters who do not plan to return to affected address

You need to change your address. Complete section 2 on the attached card to give us your new residence/mailing address.

3. Displaced Voters who have not decided on whether they will return or move

If you have not made a decision at this time, you can continue to use the address of your fire damaged property for voting. Complete section 3 on attached card to give us your new mailing address.

When you decide whether you will stay or leave, review items 1 & 2 above and update your Voter Registration record.

If you were not affected by the fire, please destroy this card.
