**Candidate Bio (Not to exceed one page):**

My first exposure to the election process was watching the tallies being read from mechanical voting machines at the fire station in my hometown in Pennsylvania where my father served in a number of elected offices.

I moved to New England to attend the Massachusetts Institute of Technology, where I graduated from a special program concentrating on the application of digital computers to instrumentation and control systems in 1979. Since that time I have been continuously developing software, and designing and implementing computer based hardware products.

I started my business, now known as LCS/Telegraphics, in 1980, to develop computer based measurement tools for scientific research, and to provide engineering development services. Most of the projects I worked on involved the interaction of people with computer systems and required very high reliability and accuracy. During that time I had the opportunity to conduct experiments and research how users interacted with computers they were using to perform complex tasks. A few years later I lead an effort to develop an early version of a modern web browser which gave me the opportunity to learn a lot about graphical user interfaces, and how people interact with computer systems that use graphical interfaces.

Subsequently in the 1980s my company changed it focus to the development of software related to input devices such as mice, touch screens, scanners and joysticks. I have developed products for very high volume commercial sales, as well as more specialized assistive technology input devices. Today, I am still actively involved in the development of software, firmware, and hardware products, as well as providing consulting and expert testimony related to input device and software technology.

I have lead and participated in a number of industry standards groups, including serving as the chairman of the Universal Serial Bus Human Interface Device Working Group, the group which wrote the standard that is used by USB mice, keyboards, and other input devices. I am very familiar with the process whereby commercial organizations determine key technology standards.

I have served as the Moderator for the Town of Newton, New Hampshire since 2002, where I am responsible for conducting all elections in the town. In New Hampshire this means hands-on participation in the process, including voting machine testing, set-up, staff training, and election day absentee ballot processing, vote counting and reporting.

In 2005 I served on the New Hampshire State Disabilities Access and Voting Systems Task Force which evaluated voting machine systems.

I am personally interested in ways to improve the technology used in the election process, and ways to ensure that the technology used enhances the accuracy and reliability of the election process.

I have been an election administrator in Alaska for nearly 20 years. Unlike the other states, Alaska's state and federal elections are conducted at the state level by the Alaska Division of Elections. We have just under 500,000 registered voters and 438 voting precincts, of which about a quarter of them are not on the road system. We are a paper ballot state that uses optical scan. Our touch screen is equipped with VVPAT and is used to meet accessibility requirements. About 1% of our voters use the touch screen.

I have been Alaska's local representative on the Standards Board since the board was initially formed. Throughout my tenure on the Standards Board, I have been actively involved in the review and recommended changes to the VVSG through my membership on the VVSG ad-hoc committee. I have also served on the election certification committee.

I have been a consistent member of the Standards Board and would be honored if selected to serve as a member of the Executive Board.

**Shelly Growden  
Election Systems Manager**

Shelly has worked as an election manager for the Alaska Division of Elections since 1991. From 1991 - 2007, Shelly served as one of four regional election supervisors for the State of Alaska. As a regional election supervisor, Shelly was responsible for all voter registration and election activities in the interior of Alaska. Her region was comprised of 101 urban and rural voting precincts throughout over 60 different communities, many of which are Alaska native villages that are not on Alaska's road system. As an election supervisor, Shelly was involved in Alaska's statewide implementation of the division's optical scan and touch screen ballot counting system, fax voting, early voting, development of poll worker training materials and development of training materials for municipal clerks.

In 2007, Shelly was appointed to serve in a statewide role for the division to oversee and manage the division's compliance with federal requirements such as the Help America Vote Act (HAVA), National Voter Registration Act (NVRA) and the Voting Right Act. In her role as Election Systems Manager, Shelly is responsible for managing the division's voter registration system, ballot tabulation system, voter outreach programs, accessibility and language assistance programs, Department of Justice preclearance, media plans and the HAVA Alaska State Plan. Shelly also served as the project manager for the replacement of the statewide registration system, for the Election Security Study conducted by the University of Alaska, Anchorage and for the Yup'ik language assistance program which included the formation of a Yup'ik translation panel consisting of seven expert speakers of varying dialects to create a Yup'ik glossary of election terms and sample ballot in this historically unwritten language.

Shelly has served as an active member of the U.S. Election Assistance Commission's (EAC) Standards Board since 2004. As a member of the Standards Board, Shelly has served on the Voluntary Voting System Guidelines (VVSG) ad-hoc committee responsible for reviewing and providing recommendations to the full Standards Board for changes to proposed voting system guidelines. Shelly has also served on the Election Certification Committee for the Standards Board and in 2007 was asked to serve as a member of the EAC Native American and Alaska Native Language Working Group.

I am a native of Omega, Indiana (population 50). Although Omega was too small to have its own town government, I developed a lively interest in the elections process that has never left me.

I received my undergraduate degree in history and political science from Indiana University, and was a student in one of the nation's first election law courses, which was offered at the Marshall-Wythe School of Law, College of William & Mary (J.D. 1981). I am a member of the California and Indiana bars.

My interest in voting system standards goes back almost to the beginning of my involvement in election administration. I served as counsel to the Indiana House and Senate Elections Committees from 1985-1990, and drafted legislation setting forth the standards and certification procedures for voting systems being used for the first time in Indiana elections.

I served as General Counsel to the Indiana State Election Board (later Commission) from 1992-1999. My duties included providing staff support and legal advice to the Indiana Voting Systems Advisory Committee, a statutory body whose membership included county election administrators and individuals with technical expertise concerning voting systems.

From 1999-2002, I served as Director of Elections for the Secretary of State of Minnesota, and supervised the voting system certification process in that state, including a revision of administrative rules concerning voting system standards.

Since 2002, I have served as Co-Director of the Election Division of the Office of the Secretary of State of Indiana. My duties include the evaluation of voting system applications, submitting recommendations to the Indiana Election Commission regarding whether voting systems should be approved, and if so, under what conditions; preparing and providing information regarding legislation to update voting system statutes; and bringing enforcement proceedings before the Indiana Election Commission when uncertified versions of voting systems have been sold for use in Indiana elections.

In 2005, I drafted legislation at the request of the Secretary of State which led to the establishment of the Voting System Technical Oversight Program (VSTOP). VSTOP is modeled on the pioneering voting system work of Kennesaw State University in Georgia, and has been established at the Bowen Center, Ball State University. During the last several years, VSTOP has successfully performed a wide variety of tasks related to voting system certification, including the first state-level testing of voting systems for certification in Indiana, and the collection and analysis of local government contracts for the purchase and maintenance of voting systems.

I currently serve as Vice-Chair of the Standards Board. I am chair of the By-Laws committee, and a member of the Resolutions committee. I also serve as Vice-President of the National Association of State Election Directors (NASSED) Executive Board.

**I have served on the Standards Board at the request of my Secretary of State since the Standards Board was formed and I appreciate that we as members have an important role in determining the future of the Voluntary Voting System Guidelines. We need to seek the balance between accurate, secure, and usable voting systems and election administration systems with which we can run elections that are affordable by the public.**

**I represent a state with a relatively small population. I understand that the needs of small population jurisdictions are quite different than the needs of large metropolitan areas, but still our voices must be heard as the EAC continues to move forward in setting standards and providing best practices for election administration.**

**If elected, I promise to listen to all points of view and help to make decisions that are the best for everyone concerned.**

**Candidate Bio (Not to exceed one page):**

**I have served as Deputy Secretary of State for North Dakota since 2003. During that time, I have been intricately involved with writing the RFP for a new statewide voting system, reviewing RFP responses from voting system vendors, interviewing vendors, writing the voting system contract, and working with the chosen vendor and their voting system through the 2004, 2006, 2008, and 2010 election cycles.**

**North Dakota is the only state without any form of voter registration. Rather than registering voters, North Dakota residents are qualified electors as long as they are of age and have not had voting privileges removed through court action. As voters appear at the polls, we keep track of their voting history on a statewide basis through our Central Voter File. Prior to my time in office, this tracking was only done on a county by county basis, but we now have a centralized database that I helped to construct and implement and we have been using it effectively since 2006.**

**During my time in office, we have implemented early voting precincts, vote centers, and vote by mail options for counties. Our objective has been to provide options within the law that counties can utilize for whatever works best for their voters because we understand that there is no such thing as a one-size-fits-all solution.**

**As a North Dakota election team, in 2010 we were able to realize one of my dreams for election administration. We built an election management system called ND VOICES, which unifies all election databases in the state allowing for a single point of entry for critical election data. For election officials, this system makes the administration of elections easier due to the integration of project management tools, helpful checklists, and task automation. For voters, more information is made available through the voter information portal, which is automatically populated through the collective work of local and state election officials.**

**I have been a member of the Standards Board since it was formed. I have served on the Nominating, Voluntary Voting System Guidelines Ad Hoc, and Military and Overseas Voting Committees as well. If elected, this would be my second term on the Executive Board. In my first term I served as Vice-Chair and then Chair of the Board and it has been my pleasure to serve.**

**Aside from my work in elections, I supervise all the additional areas of the Secretary of State's office in North Dakota. My work with these other areas, I believe, gives me a broader perspective on election administration. For example, we are currently re-writing the software to handle the business services, central indexing, and licensing aspects of our office. This helps me to understand the nuances of software creation that must adhere to established business, industry, and software design standards. I believe these are valuable interdisciplinary insights.**

She received a Juris Doctor, cum laude, from St. Louis University School of Law in 1998. She is licensed to practice law in Missouri, Illinois and Washington D.C.

In 1993, Ms. Winslow was appointed Director of Elections for St. Louis County – Missouri’s largest local election jurisdiction – by Governor Mel Carnahan. As Director, she was responsible for the administration of all aspects of state and local elections. She was active in working to amend state election laws to achieve compliance with federal law and to implement changes sought by local election officials to improve the administration of elections. She also implemented a series of technological improvements for her office and acted as liaison to state and county government.
