1.5 Interest Accrued on Federal Fund in 2019

The total interest accrued in FY2019 is \$92,697.43. The entirety of the interest is on Title I Section 101 Election Security Grant funds.

1.6 State Match Share

Alabama's Required State Match Share was determined to be \$308,020. The State Match Share will be satisfied by replacing and upgrading certain voter registration equipment used by certain state election officials. The state commenced, on the effective beginning date of the grant on March 23, 2018, meeting this obligation. Since March 23, 2018, the state has expended, with state funds alone, \$17,187.10 in printers, printer repair parts, printer maintenance kits, and barcode scanners and supporting hardware. Of the \$17,187.10 matched currently \$7,287.80 was expended in FY2019.
