During this reporting period, the Department expended \$375,026.93 in HAVA funds from two grants as follows¹:

During the FFY 2019 reporting period, we spent grant funds in accordance to our approved state plan and the HAVA act. The following is a summary of the activities for which funds were expended in this reporting period⁶.

Risk-Limiting Audit software development

During the reporting period, the Department expended \$225,217.22 in 2018 Security Grant State Match funds on enhancements to the state's Risk-Limiting Audit software. The contract with Democracy Works to further develop the software extended into 2019. The 2018 general election RLA was successful, but a few key monitoring and reporting features were completed

after the general election. The software will be used for all future state and federal election audits. This software is open source, and may be used by other states as they transition to Risk-Limiting Audits.

Grants for the Purchase and Installation of Drop-boxes and Associated Materials

During the reporting period, the Department expended \$2,977.38 in 2018 Security Grants funds and \$562.77 in 2018 Security Grant State Match funds to aid counties in purchasing and installing 24-hour ballot drop boxes⁷. In 2016, Colorado began issuing grants to counties around the state for the purchase and installation of ballot drop boxes. Counties with more than 10,000 active voters were reimbursed up to 80 percent of their costs, while counties with less than 10,000 active voters were reimbursed up to 90 percent of their costs, with a maximum reimbursement of \$4,000.00 per county. Counties could ask for reimbursement for the cost of the purchase, delivery and installation of the drop-box, along with the cost for the purchase, delivery, and installation of equipment needed to keep the box secure, including camera equipment. To date, 45 counties across the state have applied for and received this grant.

These grant funds were used to improve the administration of elections for Federal office in Colorado. In 2013, Colorado began mailing all active voters in the state a ballot. To improve both the speed and safety of returning those ballots, Colorado counties began to place ballot drop-boxes around their communities for voters to use. This grant program encouraged counties either to increase their use of drop boxes or to begin using these valuable tools. Usage of the drop boxes by voters has continued to increase, and the majority of voters now use it to return their ballots around the state.

Payments to the Colorado Department of Public Health and Environment

During the reporting period, the Department expended \$1,260 in 2018 Security Grant State Match funds for data on deceased Colorado Residents from the Colorado Department of Public Health and Environment (CDPHE)⁸. These funds were spent in support of maintaining the currency of the statewide voter registration database.

Election Preparedness for Infrastructure and Cybersecurity (EPIC) training

During the reporting period, the Department expended \$6,125.37 of Title 1 funds, \$800.39 of the 2018 Security Grant funds, and \$546.63 of the 2018 Security Grant State Matching funds to pay for hotel and travel costs for the 2018 EPIC training⁹. Alongside county election and IT officials, the Department held two hour-long tabletop exercises in September of 2018, creating real-life security situations requiring immediate response. The situations involved possible scenarios that could occur leading up to and including election day. Not only did individuals work on how

to resolve these situations, but also realize how each event impacted other areas involved with the election. To wrap up the event, county and state officials discussed what they learned, and how they were able to overcome each situation so that all officials could learn from each other and apply to their own offices. Event participants included 167 county staff, 64 moderators, 41 observers, and 15 support staff. The event was also attended by 21 press representatives.

Cybersecurity training and planning

During the reporting period, the Department expended \$1,164.82 of the 2018 Security Grant funds on two cyber-security planning and best practice sharing events. The Department spent \$533.82 to reimburse travel expenses for a county clerk to attend a panel on cyber-security at COGEL. The panel members included the Secretary of state, a department staffer, and a county clerk. The panel discussed the state cyber-security table top exercise and shared best practices and lessons learned with election officials from across the United States and from around the world. The Department spent \$631.00 to provide breakfast and lunch at a GCC/SCC joint planning meeting to discuss the joint sub-sector plan for the 2020 election.

Global Mobile

During the reporting period, the Department expended \$8,000 of Title 1 funds to improve the individual's accessibility to their voter registration, learn about voting location information and important election dates 11. The Department worked with Global Mobile, to create a mobile based platform which brought this capability to individuals in Colorado. In addition, Arapahoe County and other metro counties, utilized Global Mobile to help mail ballot voters cure signature discrepancies by using their phone. Individuals were able to accomplish this by taking a picture of their signature along with a copy of their ID to cure a ballot that couldn't otherwise be counted.

SCORE Development

During the reporting period, the Department expended \$43,096.00 of Security Grant funds for contractor development services to make enhancements and improvements to the state's centralized voter registration and election management system, known as SCORE¹². Some specific improvements to which this expenditure was devoted include working with the Colorado Department of Revenue to implement automatic voter registration, redeveloping the system to allow a 17-year old to vote in a primary if they will be 18 for the general election, changes to improve the federal reporting capabilities, and development of the new web-based SCORE system. During the reporting period, the Department expended \$81,728.88 of Security Grant funds to upgrade the SCORE firewalls to next-generation firewalls, which allow for application based blocking and additional functionality to expand SCORE capabilities.

Voting Systems Support to Counties

During the reporting period, the Department expended \$26.76 in Security Grant funds and \$3,176.71 of Security Grant State Matching funds for travel related expenses for county support. Specifically, the office spent \$3,049.83 in State Matching and \$26.76 in Security Grant funds for travel related expenses to perform software and security upgrades to new and existing voting systems. In addition, another \$126.88 was spent on travel to audit the universe of voting systems.
