

2019 HAVA ELECTION SECURITY GRANT FUNDS PROGRESS NARRATIVE

The state of Louisiana received \$5,889,487.00 in Section 101 funds to improve the administration of elections for Federal office, including to enhance election technology and making election security improvements. Due to state guidelines and regulations regarding Request for Proposals, the Department has not yet secured a contract for the procurement of a new electronic voting system; therefore, no expenditures have been made during the reporting period ending on September 30, 2019. However, the objectives presented in the project narrative submitted on June 27, 2018 are still valid.
