Analysis and Description of Activities by Budget Category:

A) Personnel

Montana did not spend grant funds for personnel employed by SOS. Montana did spend grant funds for two contracted personnel to support the ElectMT project to replace the existing statewide voter registration system. Those expenses are reflected "All Other Costs" category.

B) Equipment

Montana did not directly expend any grant funds on Equipment within the reporting period. Montana did grant subgrants to counties to purchase voting equipment – please see C.

C) Subgrants to local voting jurisdictions

Montana expended \$ 531,146 on subgrants to local voting jurisdictions. Each of the 56 counties were given the opportunity to apply for grants to be matched by 50/50 with county funds. Replacement of the out-of-date ES&S AutoMark Voter Accessibility Interface Device was prioritized in the grant process. However, counties were also able to request funds to purchase other voting tabulation equipment. Below is a table outlining the funds allocated and granted to each County.

D) Training

Montana did not expend any grant funds on Training within the reporting period.

E) All Other Costs

In 2019 Montana expended 2018 Security grant funds in support the project to replace the existing statewide voter registration system with a new system procured from BPro of South Dakota. Montana plans to spend \$2,000,000 with BPro to license and implement the TotalVote voter and election management system (<u>https://bpro.com/totalvote-solutions/</u>). Under the contract with BPro, they are paid on a completed/accepted deliverable schedule. The amount spend in the 2019 fiscal year are payments for deliverables received and approved.

Montana also expended \$71,596 for contracted Project Management and Business Analysis to assist in implementing the new system. These funds represent a portion of the required 5% match for the overall grant.

Descriptions of Major Categories of Subgrant Activities:

Descriptions of the major categories of subgrant activities local voting districts will accomplish with the funds (if the state subgranted funds during the reporting period to local election districts).

Montana, in alignment with the grant program narrative, set up a subgrant program to fund up to a total of \$750,000 of projects and purchases by the 56 Montana counties. The focus of the grants was the replacement of an outdated Voter Assist Device called the AutoMark manufactured by Election Systems and Software (ES&S). Montana law requires a paper ballot and the old AutoMark device was the only voting system for voters with disabilities to use to mark a ballot that was the same as any other ballot. During the 2019 Legislature, the law requiring a uniform ballot was adjusted to allow a different ballot to be produced by a voter assist device. ES&S applied for and received certification for their AutoMark replacement called ExpressVote. This device prints out a ballot card that shows the voters choices and is also readable by vote tabulation machines. Montana law requires any electronic voting device used must produce a paper ballots to allow for hand counting and auditing. Upgrading to a supported Voter Assistance Device increases election security and accessibility for voters using the device.

Counties applied for grants with a requirement that they match the grant funding request dollar for dollar. An initial allocation of the \$750,000 was made to allow for the purchase at least one ExpressVote device for every polling place for a county. Not all of Montana's 56 Counties applied or received subgrant funds within the 2019 reporting period.

Description of any Security Training:

A description of any security training conducted and the number of participants.

Montana did not have any security training expenses paid for by the grant within the reporting period. Montana has continued to provide security training at Election Administrator training events along with on-line IT security training. Montana is planning a table-top election security exercise in the first quarter of 2020.

Montana provided sub-grants to Counties during the reporting period. The Counties purchased or ordered the following equipment using county matching funds, Subgrant funds, and additional county funds.
