Program Categories:

2D These costs include secure and encrypted hardware equipment purchased for use in the Secretary of State's office and Ohio counties.

3D These costs include sub-grants funds provided directly to all 88 counties to assist in implementing the Secretary's cybersecurity priorities.

3F These costs include reimbursements provided to counties to have pathfinder assessments done of their county Board of Elections IT networks.

- 4D These costs include several trainings, tabletop exercises, and webinars related to the Secretary's cybersecurity priorities. Participants included Ohio Secretary of State office staff, county elections staff and officials, and other stakeholders.
- 5C These costs include software and services to upgrade and strengthen Ohio's voter registration database.
- 5D These costs include software and services to upgrade and strengthen elections-related IT networks at the Secretary of State's office and in Ohio counties.
- 5G These costs include email support and hosting services for pilot counties.
- 11C These costs include voter system database licenses, support, re-platforming, and security enhancement projects.
- 11D These costs include staffing, network/database support, disaster recovery support and equipment to obtain the achievement of the Secretary's cybersecurity plan.
