During the Election Security Grant reporting period, we spent grant funds in accordance to our approved state plan and the HAVA act. The following is a summary of the activities for which funds were expended in this reporting period .

Grants for the Purchase and Installation of Drop-boxes and Associated Materials

During the reporting period, the Department expended \$86,876.12 in Election Security Grant funds to aid counties in purchasing and installing 24-hour ballot drop boxes . In 2016, Colorado began issuing grants to counties around the state for the purchase and installation of ballot drop boxes. Counties with more than 10,000 active voters were reimbursed up to 80 percent of their costs, while counties with less than 10,000 active voters were reimbursed up to 90 percent of their costs, with a maximum reimbursement of \$10,000.00 per county. Counties could ask for reimbursement for the cost of the purchase, delivery and installation of the drop-box, along with the cost for the purchase, delivery, and installation of equipment needed to keep the box secure, including camera equipment. To date, 53 counties across the state have applied for and received this grant.

These grant funds were used to improve the administration of elections for Federal office in Colorado. In 2013, Colorado began mailing all active voters in the state a ballot. To improve both the speed and safety of returning those ballots, Colorado counties began to place ballot drop-boxes around their communities for voters to use. This grant program encouraged counties either to increase their use of drop boxes. Usage of the drop boxes by voters has continued to increase, and the majority of voters now use it to return their ballots around the state. In 2020, these drop boxes provided a safe means for voters to return their voted ballot securely in three federal elections while maintaining social distance and protecting their health and safety, and that of election workers, during the COVID-19 pandemic.

Misinformation/Disinformation

During the reporting period, the Department expended \$70,400 in Election Security Grant funds to combat and prevent foreign misinformation and disinformation from misleading voters in Colorado. We engaged in disseminating accurate information regarding voting as well as monitoring and combatting foreign misinformation and disinformation.

Rapid Response Election Security Cyber Unit (RESCU)

During the reporting period, the Department expended \$175,597.77 in Election Security Grant funds to protect Colorado's elections from cyber-attacks, foreign interference, and disinformation campaigns. RESCU is a highly-trained team of election security experts who work closely with the Department's information security team to protect against cybersecurity threats. They also work hand-in-hand with counties to increase their security and cyber awareness and preparedness.

Text2Cure

During the reporting period, the Department expended \$58,560 in Election Security Grant funds to establish and use secure electronic TEXT2CURE for the 2020 General Election. Allowing voters with a missing or discrepant signature or missing

identification for their mail ballot, the ability to cure signatures electronically.

Improvements to SCORE

During the reporting period, the Department expended \$90,872 in Election Security Grant funds to maintain and perform enhancement work on the State of Colorado's Voter Registration System (SCORE). Some specific improvements made during the reporting period include enhancements to the user management tool where systems permissions are granted, improvements to the document imaging and queueing process, and enhancements to the list maintenance queueing process to increase standardization and monitoring.
