An expenditure of \$666,790.29 was made to enable all Alabama's 67 counties to acquire election reporting management computers. An expenditure of \$39,527.00 was made to the Alabama Office of Information Technology to provide secure electronic email addresses for certain state and county election officials. An expenditure of \$312,864.99 was made to enable the State of Alabama to provide all Alabama counties access to the computerized statewide voter registration system. An expenditure of \$168,699.00 was made to enable seven Alabama counties to acquire DS200 tabulators and two Alabama counties to acquire electronic ballot marking machines for handicap voters. An expenditure of \$43,617.46 was made to enable three Alabama counties to acquire electronic poll books. An expenditure of \$39,450.00 was made to enable two Alabama counties to acquire secure voter geographic identification and placement software, commonly referred to as Geographic Information Systems software.

The state provided a match of \$19,850.00 by paying for one Alabama county to acquire secure voter geographic identification and placement software, commonly referred to as Geographic Information Systems software. The Secretary of State's office uses money from one of our larger funds (generally fund 0345 - Secretary of State Corporations Fund) for the source of our match funds. It appears that the 2021 annual report match amount was overstated. We reported \$439,000 in match but only spent \$399,997.63. The total match for the 2021 annual report should have been \$708,017.63. It appears that the 2022 semiannual report match amount was overstated. We reported \$70,230 in match but no match money was spent for the first half of 2022.
