These funds are used to strengthen our election infrastructure.

Yearly trainings are conducted for local election officials on both procedures and cybersecurity. In-person trainings were conducted in June and September, which also included table top exercises. Virtual trainings were held weekly from July through November. Those trainings were held via Zoom			
and recorded for future reference. Additionally, annual cybersecurity training is required for all SOC employees and local election officials who have access to the statewide database.
