Voting Equipment Funds were disbursed to renew the warranty and license for the ExpressVotes that were purchased with Election Security Grant funding and to purchase ExpressVote activation cards for the 2022 general election. Voting Processes Most of the funds disbursed under this category were used to supplement election worker stipends for the 2022 general election. Other disbursements were for homebound voting services and off-island absentee voting. Voter Registration Systems Funds were used to improve Guam's online voter registration and motor voter registration processes, specifically in communicating with new registrants after voter registration applications are processed and purchasing supplies necessary to make the processing of motor voter registration more efficient. Cyber & Physical Security Funds were used to purchase a new computer used to address cybersecurity vulnerabilities. Voter Education Funds were used to inform voters of registration deadlines, early voting options, and election day details for the 2022 general election. Training Funds were used for the airfare, registration fees, and per diem for election staff to attend the Council on Governmental Ethics Laws (the entity through which election staff receive training on campaign finance) 2022 Annual Conference. Funds were also used to renew membership with the National Association of State Election Directors ("NASD"). NASD is a nonpartisan professional organization that disseminates election administration best practices and information across the states and territories. Funds were also used to renew membership with Election Center, the National Association of Election Officials. Election Center is an entity that offers courses to become a Certified Elections/Registration Administrator ("CERA"). The GEC Director previously completed the coursework necessary to be CERA certified and funds were used for the registration fee for her to complete Course 15 which was required to maintain her CERA certification.
