(a) Voting Equipment Replacement and Upgrades

2. Equipment, purchased August 2018 \$3,276.00

Two laptops were purchased to upgrade and replace dedicated laptops for Election Reporting Manager for the final step of Canvass, Vote Tabulation, & Declaration of Results. Procurement and inventory documents are on file at the GEC.

Projected cost for upgraded central tabulators and election results management system based on bid submitted and awarded is \$329,136.00.

(c) Voter Registration Systems and Management

2. Equipment, purchased October 2018 \$323.88

Mic stands were purchased for updated precinct official training.

(d) Cyber Security

2. Equipment, purchased November 2018 **\$1,680.00**

One desktop computer, monitors, and uninterruptible power supply (UPS) were purchased to upgrade and replace workstation dedicated to GEC's voter registration system.

GEC's Systems and Programming Administrator G. Lujan completed the Certified Information Systems Security Professional (CISSP) preparation course and will complete the exam in FY2020.
