## HAVA Election Security Federal Fiscal Year 2018 Report

### October 1, 2018 to September 30, 2019

#### SUMMARY AND DESCRIPTION

#### Summary of expenditures aligned with budget categories and description of how the funded activities meet the goals of the plan:

On Friday, March 23, 2018, the Consolidated Appropriations Act of 2018 was signed into law. The Act included \$380 million in grants, made available to states to improve the administration of elections for Federal office, including to enhance technology and make certain election security improvements. The 2018 HAVA Election Security Fund, authorized under Title I Section 101 of the Help America Vote Act (HAVA) of 2002, allocates \$4,277,723.00 for Nevada to secure and improve election systems for federal office. The Election Security grant requires a five percent match within two years of receiving the appropriation. Nevada's \$213,886.00 match requirement was satisfied as an in-kind contribution with the purchase of replacement and upgraded voting equipment during the 2018 Federal Fiscal Year.

#### Voting Equipment

Expended during the reporting period: \$0.00

The Help America Vote Act 2018 Election Security funds were not used to purchase voting equipment during the reporting period. Nevada's Election Security budget does not allocate funds for voting equipment because Nevada's voting equipment was upgraded prior to the Election Security appropriation.

#### State Match Share (5%)

States are required to match five percent of funds awarded within two years of receiving federal funds. Nevada's \$213,886.00 match requirement was satisfied as an in-kind contribution with the purchase of upgraded voting equipment equivalent to the required match amount. Details about the equipment is listed in the section of the report for voting equipment obtained with Election Security funding.

#### Election Auditing

Expended during the reporting period: \$56,722.84

Nevada's Election Security plan seeks to accomplish two main goals: improving the security of the voting system as well as the integrity and uniformity of the administration of elections. As part of the first goal, election auditing expenses include staff development for voter registration database management. Two staff members were able to attend a national conference that outlined best practices for database management for a bottom-up system, as Nevada is currently.

Expending funds on staff development and training for voter registration database management met one goal while utilizing a new staff position (the HAVA Program Officer II) to audit and develop election procedures aligns with the second goal. The Program Officer II works with Nevada's local election officials to review and revise election procedures to proactively increase consistency and uniformity of the administration of elections for federal office. The Program Officer II visited several counties to conduct election administration training and develop statewide election procedures as needed. The new position was filled in October 2018 and incurred a cost of \$54,145.46 during the 2019 Federal Fiscal Year.

## **Voter Registration Systems**

Expended during the reporting period: \$364,765.75

The 2018 Election Security funds allowed the creation of a new full-time position, the Statewide Voter Registration List Lead (SVRL Lead). The SVRL Lead's primary responsibility is to focus on improving the security and procedures for data management and maintenance according to federal and state requirements. The SVRL Lead has worked with Nevada's three voter registration database vendors to improve and standardize the transfer of data between the counties to the State and vice versa, as well as the transfer of data with the Nevada Department of Motor Vehicles. This has been especially useful as Nevada utilizes a bottom-up system where local election officials manage and maintain a county voter registration system that feeds batch data into the statewide system to comply with federal requirements.

Election Security funds also allowed the State to hire three contractors to help analyze and implement new security features for the statewide voter registration database, both at the county and state level. Collectively, these four new positions have been able to diagram all county and state access points to the statewide voter registration list and identify necessary changes to increase the security of the voter registration data. Current projects based on their research includes reworking basic login features and security requirements to voter registration database software, creating levels of user capabilities within the database and utilizing multifactor authentication such as biometric scanners and smart cards to access the database.

These four positions incurred a cost of \$353,177.88 during the 2019 Federal Fiscal Year.

## **Cyber Vulnerabilities**

Expended during the reporting period: \$155,258.17

One of the first things for which Nevada used Election Security funding was the subgranting of funds to facilitate the purchase of Albert Sensors (network security monitoring devices) to 12 counties (the other five counties received them for free from the vendor). These devices provide alerts for traditional and network threats, allowing each county to have a stronger defense from malicious activity against their voter registration and elections data.

Nevada also began using digital email certificates from GMO GlobalSign as soon as funding was available. These email certificates have increased Nevada's digital security between State and local election officials by allowing users to prove the actual sender of an email, as well as to encrypt emails containing sensitive election or voter registration data. This annual contract incurred a cost of \$47,072.

Elections staff were also able to attend a national elections cyber security conference with grant funds. Training received there was used to implement our own cyber security workshop for all the local election officials in the state.

## **Communications**

Expended during the reporting period: \$135.53

Nevada's plan allocates funding to communication to increase public awareness about local and state resources available to registered voters to access, review, and secure their voter registration record. As such, Nevada purchased a table wrap banner to be displayed at public awareness events. Additional voter education will include messaging about measures taken by local and state election officials to collect, secure, and maintain voter registration and voting systems.

**Other**

Expended during the reporting period: \$270.06

The two full-time HAVA positions require telephone and email service in order to perform their duties.

**Other: Improve the Administration of Elections for Federal Office**

Expended during the reporting period: \$12,328.01

Local election officials mainly conduct Nevada's elections. Examples include the State's bottom-up voter registration system, physical polling locations, and part-time local election officials. As such, there is an ongoing need to support and improve the decentralized structure. Expenses made during the reporting period totaled \$11,817.01 for training and \$511 for ongoing staff and infrastructure allocations.

**SUBGRANTS****Description of subgrant activities by Budget Category:**

Nevada's Election Security Grant includes subgrant funding in two program categories. Following is a description by category.

**Voter Registration Systems**

Expended during the reporting period: \$105,095.16

Database security grants for local election jurisdictions include, but are not limited to, the implementation of intrusion detection systems and contracts. Nevada subgranted HAVA funds to 12 counties to facilitate the purchase of Albert Sensor network security monitoring devices (the other five counties received them for free from the vendor).

**Other: Improve the Administration of Elections for Federal Office**

Expended during the reporting period:\$0.00

Grants to local election jurisdictions are for (1) the implementation of ballot and voting equipment security measures, and (2) improvements to the administration of elections for federal office. Ballot and voting equipment security grants will assist local election officials with the implementation of physical and electronic security practices for the voting systems, such as the tamper evident security seals, physical security mechanisms, and video surveillance. Grants for the improvement of the administration of federal elections will provide local election officials with the ability to make proposals regarding self-assessment of local concerns and issues. Nevada's Election Security plan allocates \$150,000.00 for these two grants.

## SECURITY TRAINING

### Description of any security training conducted and the number of participants:

#### **Table Top the Vote 2019** (est. 60 participants)

Conducted by the U.S. Department of Homeland Security, the Nevada Secretary of State assisted state and local election stakeholders with participation in the exercise to identify best practices and areas for improvement in cyber incident planning, preparedness, identification and response through simulation of realistic scenarios exploring impacts to voter confidence, voting operations, and the integrity of elections.

#### **Nevada TTX** (est. 30 participants)

In July 2019 the Nevada Secretary of State's office conducted an in-person table top exercise (TTX) with county election officials from 15 of the state's 17 counties. The TTX allowed participants to role play various election security and emergency incidents in order to train how state and local election officials would respond to these incidents.

#### **Staff Development** (6 participants)

During the reporting period, state election officials attended various security trainings and staff development opportunities conducted by the National Association of Secretaries of State, Council of State Governments, the Center for Election Innovation and Research, and the National Association of State Election Directors.
