Upgrade elections-related computer systems to address cybersecurity vulnerabilities

Central Voter Registration System (CVRS) Upgrade

Expended Funds: \$460,726.14 Obligated: \$419,700.00

The Department of State is working with vendors to build a new voter registration system, replacing the prior application which was in place for 14 years. The new system enhances the security of voter registration data and streamlines election processes for the Department of State, Board of Elections, and Rhode Island's 39 cities and towns. The state will own the source code and will be able to perform timely updates and maintenance of the system.

Laptops

Expended Funds: \$3,747.00 Obligated: \$191.00

The Department of State replaced two Voter ID laptops that were running Windows 7 (which will no longer be supported as of January 2020). The Department also replaced one Election employee's workstation which was running Windows 7.

Implement cybersecurity best practices

Database Activity Monitoring (DAM) and File System Security

Expended Funds: \$183,364.80

The Department of State purchased and implemented a DAM which monitors the Central Voter Registration System (CVRS) and provides alerts based on activity and prevents unauthorized activities. A DAM is also important technology for protecting sensitive data from external cyber criminals. Applied in conjunction with a File System Security application, a protection from ransomware is an added layer of security.

Asset Management Appliance and Software

Expended Funds: \$45,468.40

The Department of State purchased and implemented an Asset Management appliance which tracks all endpoints (computers, phones, etc.) on a given network and any vulnerabilities, along with the software installed on those devices. This adds a critical layer of security to better understand what is on the Department's network and what threats need to be defended against.

Security Information and Event Management (SIEM) System

Expended Funds: \$177,535.20

The Department of State purchased and implemented the SIEM system which provides real-time analysis of security alerts generated by applications and hardware on the network. It consumes logs from both the DAM and Asset Management appliance, along with logs from application servers, domain controllers, firewalls, etc. The SIEM provides alerts of security issues and uses machine learning and policies the Department creates to initiate action when certain events happen. For instance, it can quarantine a device if it detects there may be abnormal behavior.

Software Assurance for Database Platform

Expended Funds: \$10,000.00

As part of a continuing effort to secure the elections infrastructure, software assurance was purchased on the new database software platform that will allow the Department of State to upgrade to the latest version of the software when end of support arrives or vulnerabilities arise in the version being run in the environment.

Cyber Security Implementation

Expended Funds: \$26,541.00 Obligated: \$147,888.00

The Department of State purchased a subscription server for Application Vulnerability Scanning which dynamically scans the application for any vulnerabilities while in production. Additionally, the product scans all source code to look for vulnerabilities with the code. The Department also purchased specific endpoint protection software for the Central Voter Registration System.

Cyber Security Summit

Obligated Funds: \$4,611.00

Secretary Gorbea (the Department of State) convened over 140 local elections and IT officials for the second Cyber Security Summit. The half-day forum gave Rhode Island election officials from nearly every city and town an opportunity to learn from national and statewide cybersecurity experts on several topics, including:

- Current best practices on the state and local level to secure election systems ahead of 2020
- Combating misinformation and disinformation campaigns
- Common causes of data breaches and ways to prevent them
- Actions being taken on the federal level to protect elections

Improve elections administration for federal office

(Enhance Technology)

Mail Ballot Envelope Industrial Opener

Expended Funds: \$9,998.00

The Board of Elections acquired one unit during FFY 2018 and one during FFY 2019. The units greatly improved the process of sorting and opening the 30,000-plus mail ballots voted in the 2018 general election.

Polling Place Operational Improvement

Expended Funds: \$129,856.00

The Board of Elections purchased 20 additional voting machines for the 2018 election cycle. The Board used the machines in high-turnout polling places to ensure voters did not have to wait in long lines to cast a ballot. The purchase order was created before the reporting period ended (September 30, 2019) but the funds were expended after the reporting period ended.

E-Poll Book Support

Expended Funds: \$54,050.00

The Board of Elections worked with a vendor to prepare the e-poll books and provide support for all 421 polling places in Rhode Island for the 2018 elections.

Online Voter Registration Database Server

Expended Funds: \$15,261.83

The Department of State purchased a new database server with an updated server operating system. The current version of the operating system will reach its end of life in 2020.

Local Grant Program

Expended Funds: \$29,705.69 Obligated Funds: \$9,583.41

The Department of State granted Rhode Island's 39 cities/towns a combined \$100,000 for improvements to elections processes. More than half of the cities/towns have requested funds for multiple items including: security assessments, upgraded computers, and secure transport methods.
